## COMMISSION STAFF'S RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND NOTICE

On April 5, 2021, Sig Magnolia LP (Sig Magnolia) filed a petition for streamlined expedited release from Dobbin Plantersville Water Supply Corporation's (Dobbin Plantersville WSC) water certificate of convenience and necessity (CCN) number 11052 under Texas Water Code (TWC) § 13.2541 and 16 Texas Administrative Code (TAC) § 24.245(h). Sig Magnolia asserts that the land to be released is at least 25 contiguous acres, is not receiving water service, and is located in Montgomery County, which is a qualifying county. Sig Magnolia filed supplemental information on April 26, 2021, May 4 and 7, 2021.

On May 6, 2021, the administrative law judge (ALJ) filed Order No. 2, establishing a deadline of May 27, 2021 for the Staff of the Public Utility Commission of Texas (Staff) to file comments regarding the administrative completeness of the petition and notice. Therefore, this pleading is timely filed.

### I. ADMINISTRATIVE COMPLETENESS

Staff has reviewed the petition and supplemental information, and, as detailed in the attached memorandum from Patricia Garcia of the Infrastructure Division, recommends that the petition is administratively complete. Staff's recommendation on administrative completeness is not a comment on the merits of the petition.

#### II. NOTICE SUFFICIENCY

Under 16 TAC § 24.245(h)(3)(f), a landowner seeking streamlined expedited release must provide proof that a copy of the petition has been mailed to the current CCN holder via certified mail on the day that the landowner submits the petition to the Commission. Sig Magnolia stated that it mailed a copy of its petition to the CCN holder, Dobbin Plantersville WSC, by certified mail

on the day the petition was filed with the Commission. Sig Magnolia also included in its petition a statement indicating a copy of the petition was sent via certified mail to Dobbin Plantersville WSC on the date the petition was filed. Accordingly, Staff recommends that the notice is sufficient.

### III. PROCEDURAL SCHEDULE

Under 16 TAC § 24.245(h)(7), there is an expedited deadline of 60 days for approval of the requested release that begins once the ALJ issues an order finding a petition administratively complete. Staff recommends that the petition be found administratively complete. Therefore, Staff proposes the following procedural schedule and requests that the ALJ populate the deadlines accordingly when the ALJ issues that order.

On April 5, 2021, Sig Magnolia LP (Sig Magnolia) filed a petition for streamlined expedited release from Dobbin Plantersville Water Supply Corporation's (Dobbin Plantersville WSC) water certificate of convenience and necessity (CCN) No. 11052 in Montgomery County, under Texas Water Code (TWC) § 13.2541(b) and 16 Texas Administrative Code (TAC) § 24.245(h). Sig Magnolia asserts that the land is at least 25 contiguous acres, is not receiving water service, and is located in Montgomery County, which is a qualifying county.

Sig Magnolia submitted a sworn affidavit attesting that the property was not receiving water service from 11052 and a warranty deed confirming Sig Magnolia's ownership of the tract of land. In addition, on April 26, 2021, Sig Magnolia submitted sufficient maps and digital data for determining the location of the requested release area within Dobbin Plantersville WSC's certificated service area. The total property is approximately 665.8 acres. The requested area to be released from the Dobbin Plantersville CCN No. 11052 is approximately 665.8 acres.

The petition also includes a statement indicating a copy of the petition was sent via certified mail to Dobbin Plantersville WSC on the date the petition was filed with the Commission. Dobbin Plantersville WSC submitted a motion to intervene on May 4, 2021. The motion to intervene was granted by the administrative law judge on May 12, 2021.

Based on the mapping review by Ms. Montes and my technical and managerial review of the information provided by Sig Magnolia, I recommend the petition be deemed administratively complete and accepted for filing.
