**ORDER NO. 11**  
**GRANTING MOTION AND ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses Commission Staff's March 30, 2022 motion to clarify the procedural schedule following the Commission's order granting streamlined expedited release on January 31, 2022. Commission Staff contends that Dobbin Plantersville Water Supply Corporation's motion for reconsideration is deemed denied under 16 TAC § 22.123(b)(6)(A), as no Commissioner submitted a ballot to place the motion on an open meeting agenda. Commission Staff recommends a procedural schedule for continued processing to the appraisal process in this proceeding.

On March 30, 2022, SIG Magnolia LP filed a response to Commission Staff's motion, agreeing with the clarification.

The administrative law judge grants Commission Staff motion and establishes the following procedural schedule for continued processing as proposed:

Deadline for the petitioner and the CCN holder to select an agreed upon appraiser	February 10, 2022

Deadline for Commission's final order determining the amount of monetary compensation, if any, owed by the petitioner to the CCN holder	Within 60 days after appraiser's report
Deadline for the petitioner to pay any compensation due to the CCN holder	Within 90 days of the Commission's final order on compensation

<b><i>In the event the petitioner and the CCN holder are unable to select an agreed-upon appraiser</i></b>	
Expedited release granted	January 31, 2022
Deadline for reports from the petitioner's appraiser and from the CCN holder's appraiser	April 11, 2022
Deadline for Commission Staff's appraiser's report	May 11, 2022
Deadline for Commission's final order determining the amount of monetary compensation, if any, owed by the petitioner to the CCN holder	Within 60 days after Commission receives the final appraisal
Deadline for the petitioner to pay any compensation due to the CCN holder	Within 90 days of Commission's final order on compensation
