**ORDER NO. 3
FINDING NOTICE SUFFICIENT**

This Order addresses the sufficiency of the notice of the April 1, 2021 application of Live Oak Hills and Flag Creek Ranch Water Systems and CSWR-Texas Utility Operating Company, LLC for the sale, transfer, or merger of facilities and associated acreage in Llano and McCulloch counties. On April 5 and May 5 and 6, 2021, the applicants filed supplemental information.

On June 7, 2021, the applicants filed an affidavit attesting that notice was provided to current customers, neighboring utilities, and affected parties on June 4, 2021.

On June 16, 2021, Commission Staff recommended that notice be found sufficient.

The administrative law judge finds the notice sufficient. The applicants meet the notice requirements under 16 Texas Administrative Code (TAC) § 239(c).

The following procedural schedule applies for continued processing:

Notice completed	June 4, 2021
Deadline to intervene	July 6, 2021 ¹
Deadline for Commission Staff to request a hearing or file a recommendation on approval of the sale and on the certificate of convenience and necessity amendment	August 4, 2021
Deadline for parties to file a response to Commission Staff's recommendation on approval of the sale	August 18, 2021
Deadline for parties to file a joint motion to admit evidence and proposed order approving sale and allowing transaction to proceed	September 1, 2021

¹ Under 16 TAC § 24.239(b), the intervention period must not be less than 30 days unless good cause is shown. Notice was mailed on June 4, 2021. Therefore, 30 days after June 4, 2021 is July 4, 2021. Because July 4, 2021 falls on a Sunday and the Commission is closed for business on Monday, July 5, 2021, the deadline for intervention is Tuesday, July 6, 2021 under 16 TAC § 22.4(a).

² Under 16 TAC § 24.239(a) and (i), the deadline for Commission action is 120 days after the mailing or publication of notice, whichever occurs later. One hundred and twenty days after June 4, 2021 is October 2, 2021. Because October 2, 2021 falls on a Saturday, the deadline for Commission action is Monday, October 4, 2021 under 16 TAC § 22.4(a).
