## CSWR-TEXAS UTILITY OPERATING COMPANY, LLC'S RESPONSE TO ORDER NO. 8 AND CLARIFICATION REGARDING FINAL TARIFF

In Order No. 8, the presiding officer directed CSWR-Texas Utility Operating Company, LLC ("CSWR Texas" or "the Company") and Commission Staff (collectively, the "Parties") to supplement the joint motion to admit evidence filed on January 4, 2022, and indicate the correct tariff by January 28, 2022; therefore, this pleading is timely filed.

The Parties submitted the joint supplemental motion and final tariff on January 4, 2022. Because the final tariff attached to the joint supplemental motion is cumulative of all systems operated by CSWR Texas, it contains the rate schedules for each system approved by this Commission in other recent sale, transfer, or merger ("STM") dockets, including Docket No. 51089. However, Page 16 of the tariff attached to the joint supplemental motion contains the rate schedule that will be in place for the subject systems in this proceeding, as recommended by Commission Staff. CSWR Texas has confirmed with Staff and is authorized to state that the final tariff filed with the joint supplemental motion on January 4, 2022, is the correct version of the tariff.

Based on this clarification, CSWR Texas respectfully requests that the presiding officer issue the Notice of Approval based on the final tariff filed with the joint supplemental motion and grant such other relief to which the Company is justly entitled.
