STATUS REPORT NO. 4

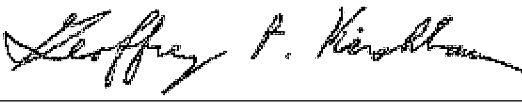
COMES NOW T&W Water Service Company (T&W or Applicant) and files this Status Report No. 4 regarding the status of efforts to conclude the transaction, address customer deposits, and submit evidence of same.

On April 9, 2021, T&W Water Service Company and Belle Oaks Water and Sewer Co. (Belle Oaks) (collectively, Applicants) filed with the Public Utility Commission of Texas an application for sale, transfer, or merger of facilities and certificate rights in Jefferson County, Texas. Specifically, T&W Water seeks approval to acquire facilities and to transfer water service area held under Belle Oaks' certificate of convenience and necessity (CCN) number 13067 and to acquire facilities and to transfer sewer service area held under Belle Oaks' CCN No. 20965. Applicants also seek the amendment of T&W Water's water CCN number 12892, the cancellation of Belle Oaks' water and sewer CCN numbers, and the issuance of a new sewer CCN number to T&W Water. The requested water service area includes approximately 450 acres, and the requested sewer service area includes approximately 445 acres. On November 19, 2021, the Commission issued an order approving the Applicants' proposed transaction to proceed.¹

The Applicants are working diligently on items needed to close the approved transaction and are targeting to close the transaction in the coming months. However, the transaction is not closed at this time.

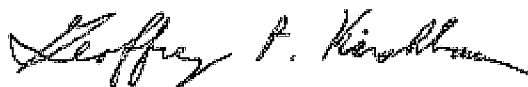
