



Re: CCN Water Service Area Transfer Agreement between the City of Austin and Forest Oaks Mobile Homes, LLC

# Dear Commission:

I represent Professional Contract Services, Inc. ("PCSI"), owner of a tract in Travis County partially in the service area of the City of Austin (the "City") under CCN No. 11322 and partially in the service area of Forest Oaks Mobile Homes, LLC ("Forest Oaks") under CCN No. 12086. Both the City and Forest Oaks are retail public utilities.

The City and Forest Oaks have entered into an agreement pursuant to Texas Water Code § 13.248, whereby Forest Oaks is voluntarily relinquishing the 5.47 acres of its service area on PCSI's property to the City so that the City may provide continuous and adequate water service to the entirety of the PCSI tract. No other landowners are affected by the agreement. I have attached the fully executed agreement, including mapping exhibits showing the area to be transferred. The parties have authorized me to file and process this application.

With respect to the public notice requirements of 16 Texas Administrative Code § 24.253(c)(2) and (3), the Agreement includes Exhibit E, the minutes from the March 4, 2021 Austin City Council Meeting approving the negotiation and execution of the Agreement (Consent Agenda Item 8), and Exhibit F, an affidavit of City Water Director Greg Meszaros attesting to the fact that notice was properly provided. Forest Oaks is a private limited liability company not subject to notice provisions. No customers are being transferred as part of this transaction.

Please let me know if the Commission requires any further information or documentation for approval of the agreement.

### WATER SERVICE AREA TRANSFER AGREEMENT

THIS WATER SERVICE AREA TRANSFER AGREEMENT (the "Agreement") is made and entered into by and between the City of Austin ("City"), a home rule municipality organized and existing under the laws of the State of Texas, and Forest Oaks Mobile Homes, LLC ("Forest Oaks") a retail public utility and Texas limited liability company. The City and Forest Oaks are each a "Party." Collectively, they are the "Parties." This Agreement is effective on the date that the last Party signs the Agreement (the "Effective Date").

## **RECITALS**

**WHEREAS,** Forest Oaks is the holder of Certificate of Convenience and Necessity No. 12086 (the "Forest Oaks CCN"), which includes a certain service area with boundaries within Travis County, Texas;

**WHEREAS,** the City is the holder of Certificate of Convenience and Necessity No. 11322 (the "*City CCN*"), the boundaries of which are within Travis, Hays, and Williamson Counties, Texas;

**WHEREAS,** Texas Water Code § 13.248 authorizes contracts between retail public utilities designating areas to be served and customers to be served by those retail public utilities, when approved by the Public Utility Commission ("*PUC*") after public notice and hearing;

WHEREAS, the Forest Oaks CCN and the City CCN boundaries are adjacent to each other;

WHEREAS, Professional Contract Services, Inc. ("PCSI") is the owner of a tract of land containing approximately 13.198 acres, being more particularly described as Lots 1 and 2, Block A, FM 1626 OFFICE WAREHOUSE SUBDIVISION, a subdivision in Travis County, Texas, according to the map or plat thereof recorded as Document No. 200600080 of the Official Public Records of Travis County, Texas (the "PCSI Tract"), a portion of which is located in the City CCN and a portion of which is located in the Forest Oaks CCN;

**WHEREAS,** PCSI has requested that the portion of the PCSI Tract located within the Forest Oaks CCN (the "*Transfer Tract*") be transferred from the Forest Oaks CCN to the City CCN and Forest Oaks and PCSI have reached an agreement to accommodate such a request;

**WHEREAS**, the Transfer Tract is mapped on Exhibit A (General Location Map), Exhibit B (Detailed Map) and Exhibit C (Survey) attached hereto and is more particularly described by metes and bounds on Exhibit D (Legal Description) attached hereto;

**WHEREAS**, the Parties desire to transfer certification for the Transfer Tract from the Forest Oaks CCN to the City CCN in accordance with the terms of this Agreement;

**WHEREAS**, there are no customers or facilities located on the Transfer Tract and Forest Oaks has never provided service to the Transfer Tract;

**NOW THEREFORE,** for the mutual promises and covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

# **AGREEMENT**

- 1. Purpose. This Agreement shall be a "contract" designating areas and customers to be served by the Parties in accordance with Texas Water Code § 13.248.
- 2. Transfer of the Transfer Tract. Forest Oaks transfers and conveys to the City, and the City accepts from Forest Oaks, the Transfer Tract; and the Parties thereby agree to modification of the boundaries of their water CCNs, accordingly. There are no customers or facilities located on the Transfer Tract and, therefore, none are being transferred. Forest Oaks agrees to take all necessary steps and pay all costs to prepare, file and advance the application(s) at the PUC necessary to transfer the Transfer Tract from the Forest Oaks CCN to the City CCN. The City agrees to cooperate with Forest Oaks in advancing such application(s) should the need arise. The Parties agree that PCSI may, at its expense, take any such actions to prepare, file and advance such application(s) on behalf of Forest Oaks.
- 3. <u>No Continuing Obligation to Serve.</u> The Parties agree that, upon PUC approval of the application(s) to transfer the Transfer Tract from Forest Oaks CCN to the City CCN, Forest Oaks shall have no further obligation to provide retail water service to the Transfer Tract.

5. <u>Applicable Law.</u> This Agreement shall be governed by, and construed in accordance with, the Constitution and the laws of the State of Texas.

- **6.** Entire Agreement. This Agreement reflects the entire agreement and supersedes all prior and contemporaneous agreements and understandings, both written and oral, between the Parties with respect to the subject matter thereof.
- Parties to each other, except with regard to other or additional requirements that may apply to documents served on all parties as provided in 16 Tex. Admin Code § 22.74. When this Contract requires the Parties to provide notice to each other, the notice shall be in writing. Notices must be addressed, hand-delivered, or emailed only to the person designated for receipt of notice. A mailed notice shall be considered delivered three (3) business days after postmarked if sent by U.S. Postal Service Certified or Registered Mail, Return Receipt Requested, postage prepaid. Hand-delivered notices are considered delivered only when the addressee receives those notices. Notices delivered by e-mail are considered delivered three (3) business days after transmittal or when received by the addressee whichever is earlier. The Parties may make routine communications by first class mail, email, or other commercially accepted means. Notices and routine communications to the City and Forest Oaks shall be addressed as follows:

8. <u>Successors and Assigns.</u> This Agreement shall bind the Parties and their legal successors, but shall not otherwise be assignable by any Party without prior written consent of the other Party, whose consent shall not be unreasonably withheld. All of the respective obligations of each Party shall bind that Party and shall apply to and bind any successors or assigns of that Party.

- 9. <u>Venue.</u> Actions taken by either Party in connection with this Agreement shall be deemed to have occurred in Travis County, Texas.
- 10. Recitals. The above recitals are true and correct and are incorporated into this Agreement for all purposes.
- 11. <u>Multiple Originals.</u> This Agreement may be executed in a number of counterparts, each of which shall be for all purposes deemed to be an original, and all such counterparts shall together constitute and be one and the same instrument.
- 12. <u>Authority.</u> The Parties represent that the individuals named below are duly authorized to execute this Agreement on behalf of their respective Party.
- 13. <u>Enforceability.</u> The Parties agree that this Agreement constitutes the legal, valid, and binding obligation of each Party hereto, enforceable in accordance with its terms, and that each Party is entering into this Agreement in reliance upon the enforceability of this Agreement.






