**COMMISSION STAFF’S REQUEST FOR EXTENSION**

On April 9, 2021, CPR Water Supply Company, LLC (CPR Water) filed an application to obtain a water certificate of convenience and necessity (CCN) in Smith County. The requested service area consists of 151 acres and zero current customers. CPR Water filed supplemental information on June 8 and 11, and November 15 and 30, 2021.

On November 12, 2021, the administrative law judge (ALJ) filed Order No. 7, requiring the Staff (Staff) of the Public Utility Commission (Commission) to provide final maps, certificates, and tariffs to CPR Water for review and consent by December 7, 2021.

**I. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On November 3, 2021, Staff filed its third request for information (RFI) to CPR Water. In Staff 3-8, Staff again requested that CPR Water provide the letter from the Texas Commission on Environmental Quality (TCEQ) approving the construction of the distribution system necessary to provide service to the requested area.

CPR Water’s response to Staff 3-8 was filed on November 30, 2021. That response consists of a *conditional* approval letter, which includes a list of conditions CPR Water must meet before TCEQ grants its final approval. Therefore, Staff filed its fourth RFI on December 3, 2021 to determine whether CPR Water has in fact obtained the final approval letter from TCEQ for the distribution system necessary to serve the requested area. Staff requires the requested information for further processing of this docket. Therefore, Staff respectfully requests an extension until January 7, 2021 to permit CPR Water the opportunity to respond to Staff’s Fourth RFI and file the final TCEQ final approval letter and for Staff provide final maps, certificates, and tariffs to CPR Water for review and consent.

## **II. CONCLUSION**

Staff respectfully requests the issuance of an order extending the deadline for Staff to provide final maps, certificates, and tariffs to CPR Water for review and consent until January 7, 2021.
