COMMISSION STAFF'S REQUEST FOR EXTENSION

On April 9, 2021, Brazos Valley Septic & Water, Inc. (Brazos Valley) and CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) (collectively, Applicants) filed an application for approval of the sale and transfer of facilities and certificate rights in Robertson County. The Applicants seek approval to sell and transfer all of Brazos Valley's facilities and certificated service area under water certificate of convenience and necessity (CCN) number 13094 to CSWR-Texas's water CCN number 13290 and the cancellation of Brazos Valley's water CCN. The requested area consists of a total of 125.10 acres and 16 customer connections. The Applicants filed supplemental information on May 4, 2021.

On April 13, 2021, the administrative law judge filed Order No. 1, requiring the Staff of the Public Utility Commission of Texas (Staff) to file a recommendation on administrative completeness of the application and propose a procedural schedule by May 10, 2021. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. The Applicants filed supplemental mapping information on May 4, 2021. Staff needs additional time to review those maps. Therefore, Staff respectfully requests an extension of time until June 3, 2021 to file its recommendation on administrative completeness of the application and propose a procedural schedule.

II. CONCLUSION

Staff respectfully requests the deadline for Staff to file its recommendation on administrative completeness of the application be extended until June 3, 2021.
