# CSWR-TEXAS UTILITY OPERATING COMPANY, LLC'S MOTION TO WITHDRAW APPLICATION WITHOUT PREJUDICE

### I. Background

On April 9, 2021, CSWR- Texas Utility Operating Company, LLC ("CSWR Texas") filed an application for sale and transfer of Brazos Valley Septic and Water, Inc.'s ("Brazos Valley") water facilities and water service area under certificate of convenience and necessity ("CCN") number 13094 to CSWR-Texas Utility Operating Company, LLC ("CSWR Texas") under CCN number 13290 ("Application").

#### II. Termination of STM Agreement and Motion to Withdraw

CSWR Texas and Brazos Valley have executed a Termination Notice, which is attached as Exhibit A. Pursuant to 16 Tex. Admin. Code § 22.181(g), CSWR Texas files this motion to withdraw its Application. Because Brazos Valley and CSWR Texas have terminated their sales agreement, the Application is now moot. Additionally, CSWR Texas has not presented its direct case, and is therefore entitled to withdraw its Application pursuant to the rule. Therefore, CSWR Texas respectfully requests that its Motion to Withdraw Without Prejudice be granted.
