**COMMISSION STAFF'S TWENTY FIFTH STATUS UPDATE**

On April 15, 2021, Inline Development Inc. (Inline) filed an application under 16 Texas Administrative Code § 24.25(b) for approval of a pass-through rate change related to an increase in fees imposed on the utility by North Harris County Regional Water Authority.

On July 22, 2021, the administrative law judge (ALJ) filed a notice directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a status report on abatement beginning on September 1, 2021 and continuing monthly thereafter. Therefore, this pleading is timely filed.

**I. STATUS UPDATE**

Inline has filed Docket No. 54729 to receive Commission approval for the transfer of facilities and CCN from Inline Development Inc. to Inline Utilities LLC. In that docket, Inline Staff will continue to work with Inline to ensure that the STM is completed as soon as possible and anticipates the conclusion of that docket shortly. After the conclusion of Docket No. 54729, the parties will file a request to unabate this docket. Consistent with the ALJ's Order filed on July 22, 2021, Staff will provide another status update on November 13, 2023.

**II. CONCLUSION**

Staff respectfully provides this status update on abatement and will file another status update on November 13, 2023.
