JOINT MOTION TO ADMIT SUPPLEMENTAL EVIDENCE

Inline Utilities, LLC (Inline) and the Staff of the Public Utility Commission of Texas (Staff) (collectively, the Parties) file this Joint Motion to Admit Supplemental Evidence (Motion). In support thereof, the Parties show the following:

I. BACKGROUND

On April 15, 2021, Inline Development, Inc. filed its Application for a Pass-Through Rate Change under 16 Texas Administrative Code (TAC) § 24.25(b) related to the increase in fees imposed by North Harris County Regional Water Authority (Application). On May 15, 2024 the presiding Administrative Law Judge (ALJ) issued Order No. 14, ordering Inline to provide clarification on whether notice was provided to customers at the time the Application was originally filed, and requiring Staff to file a recommendation on the effective date of Inline's pass-through rate change. Inline and Staff filed responses to Order No. 14 on May 24, 2024, and May 31, 2024, respectively. On June 3, 2024, the ALJ's Order No. 15 found the Application, as supplemented, administratively complete and established a deadline of June 10, 2024, for the Parties to file a joint motion to admit the respective responses to Order No. 14 into evidence in this Docket. This motion is timely filed.

II. JOINT MOTION TO ADMIT EVIDENCE

The Parties move to admit the following documents into the evidentiary record of this proceeding:

1. Inline's Response to Order No. 14 Requiring Clarification of Notice, filed on May 24, 2024 (Interchange Item No. 70); and
2. Commission Staff's Recommendation on Administrative Completeness, Notice, and Effective Date, filed on May 31, 2024 (Interchange Item No. 71).


III. CONCLUSION
