## **COMMISSION STAFF'S REQUEST FOR EXTENSION**

On April 16, 2021, Monarch Utilities I, L.P. (Monarch) filed an application to amend its water certificate of convenience and necessity (CCN) No. 12983 and sewer CCN No. 20899 in Parker County. The application proposes to add 617 acres to Monarch's service area. Staff (Staff) of the Public Utility Commission (Commission) of Texas filed its recommendation on final disposition on November 22, 2021. Monarch filed supplemental information on January 21, 2022.

On January 21, 2021, the administrative law judge (ALJ) filed Order No. 13, directing the parties to jointly file proposed findings of fact and conclusions of law by January 25, 2021. Therefore, this pleading is timely filed.

## I. REQUEST FOR EXTENSION

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Monarch filed supplemental information on January 21, 2022. Staff and Monarch are working together to finalize the required documents for filing. Staff respectfully requests that the parties' deadline to jointly file proposed findings and fact and conclusions of law be extended to January 31, 2021.

### II. CONCLUSION

Staff respectfully requests an order extending the parties' deadline to file proposed findings of fact and conclusions of law to January 31, 2021.
