JOINT MOTION TO ADMIT EVIDENCE AND REMAND PROCEEDING

On July 9, 2021, Southwestern Electric Power Company (SWEPCO) and Staff of the Public Utility Commission of Texas (Staff) jointly filed an unopposed proposed order resolving all issues in this proceeding. Accordingly, SWEPCO files this Joint Motion to Admit Evidence and Remand Proceeding to the Commission. SWEPCO is authorized to represent that Staff supports this motion and Texas Industrial Energy Consumers, the only other party to this proceeding, does not oppose it.

I. Motion to Admit Evidence

SWEPCO requests that the Administrative Law Judge (ALJ) admit the following items into evidence so that the Commission may consider the proposed order:

2. SWEPCO's Proof of Notice filed May 14, 2021(Interchange Item No. 4);
3. Errata to the Testimony of Michael D. Deibel and Schedule G filed June 11, 2021 filing (Interchange Item No. 12);

4. Commission Staff's final recommendation including all attached memoranda filed July 1, 2021 (Interchange Item No. 19); and
5. Unopposed Proposed Order filed July 9, 2021.

II. Motion to Remand Proceeding

The unopposed proposed order filed July 9, 2021 addresses and resolves all issues in this proceeding. SWEPCO requests that the ALJ enter an order dismissing this proceeding from the State Office of Administrative Hearings docket and remanding it to the Commission for consideration of the proposed order.


