**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On May 10, 2021, CCD-North Sky, LLC (North Sky) filed a petition with the Public Utility Commission of Texas (Commission) requesting streamlined expedited release from Marilee Special Utility District's (Marilee SUD) water certificate of convenience and necessity (CCN) number 10150 under Texas Water Code (TWC) § 13.2541 and 16 Texas Administrative Code (TAC) § 24.245(h). North Sky asserts that the land to be released is at least 25 contiguous acres, is not receiving water service, and is located in Collin County, which is a qualifying county. On June 16, 2021, Marilee SUD filed a motion to dismiss North Sky's petition. On June 29, 2021, North Sky filed a response to Marilee SUD's motion to dismiss.

On June 23, 2021, the administrative law judge (ALJ) filed Order No. 4, requiring Commission Staff (Staff) to file a reply to Marilee SUD's motion to dismiss and to the petitioners' response to Marilee SUD's motion to dismiss by July 7, 2021. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On June 16, 2021, Marilee SUD filed a motion to dismiss North Sky's petition for expedited release from Marilee SUD's CCN, in part because the property is receiving service through an active residential meter within the requested area. Staff notes that Order No. 3 established a July 7, 2021 deadline for North Sky to file supplemental information to cure deficiencies in its petition. Staff understands that North Sky intends to amend the requested area as part of a supplemental filing by July 7, 2021. In order to allow Staff an opportunity to evaluate the impact of the supplemental filing, Staff respectfully requests that its deadline to file a reply to Marilee SUD's motion to dismiss and to North Sky's response to the motion to dismiss be extended until July 16, 2021.

## II. CONCLUSION

Staff respectfully requests that its deadline to file a reply to Marilee SUD's motion to dismiss and to North Sky's response to the motion to dismiss be extended until July 16, 2021.
