**PETITIONER’S RESPONSE TO MARILEE SPECIAL UTILITY DISTRICT’S  
SUPPLEMENTAL MAPPING**

CCD-North Sky, LLC (the “Petitioner”) files this Response to Marilee Special Utility District’s (“Marilee’s”) Supplemental Mapping and in support thereof, respectfully shows as follow

On May 21, 2021, Petitioner filed its petition for streamlined expedited release of certain property from Marilee’s water Certificate of Convenience and Necessity (“CCN”) No. 10150 in Collin County, under Texas Water Code §13.2541(b) and 16 Texas Administrative Code §24.245(l). Petitioner filed an amended petition and digital shapefiles on July 6, 2021. Petitioner’s entire tract is approximately 220.04 acres (the “Overall Property”). Petitioner seeks release of 219.67 acres (the “Requested Area”) that does not include a water meter or residential connection.

On July 29, 2021 Marilee filed Supplemental Mapping (the “Supplement”) in response to Order No. 6. The Supplement does not accurately reflect the 219.67 acre Requested Area. Instead, it represents the Overall Property. Petitioner’s amended petition and digital shapefiles contain the proper mapping for the Requested Area and Overall Property.

For the above reasons, Petitioner respectfully requests that the Commission consider the proper mapping in this matter and deny Marilee’s Motion to Dismiss.
