## COMMISSION STAFF'S REQUEST FOR EXTENSION OF TIME

On May 10, 2021, CCD-North Sky, LLC (North Sky) filed a petition with the Public Utility Commission of Texas (Commission) requesting streamlined expedited release from Marilee Special Utility District's (Marilee SUD) water certificate of convenience and necessity (CCN) number 10150 under Texas Water Code (TWC) § 13.2541 and 16 Texas Administrative Code (TAC) § 24.245(h). North Sky asserts that the land to be released is at least 25 contiguous acres, is not receiving water service, and is located in Collin County, which is a qualifying county. On June 16, 2021, Marilee SUD filed a motion to dismiss North Sky's petition. On June 29, 2021, North Sky filed a response to Marilee SUD's motion to dismiss. On July 6, 2021, North Sky amended its petition and mapping data to revise the requested area. On July 28, 2021, Marilee SUD filed supplemental maps.

On July 20, 2021, the administrative law judge (ALJ) filed Order No. 6, establishing a deadline of August 11, 2021 for the Staff of the Public Utility Commission of Texas (Staff) to file comments on the maps filed by Marilee SUD. Therefore, this pleading is timely filed.

## I. REQUEST FOR AN EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to evaluate the sufficiency of North sky's maps in comparison to Marilee SUD's supplemental maps. Accordingly, Staff respectfully requests the entry of an order extending the deadline for Staff to file comments on the maps filed by Marilee SUD to August 27, 2021.

#### II. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to August 27, 2021 file comments on the maps filed by Marilee SUD.
