**COMMISSION STAFF’S RECOMMENDATION ON SUFFICIENCY OF NOTICE**

On May 13, 2021, Undine Development, LLC (Undine) filed an application to amend its certificate of convenience and necessity (CCN) in Travis County, Texas. Undine holds sewer CCN number 20948. The requested service area consists of 17 acres, zero existing connections, and zero proposed connections. Undine filed supplemental information and its proof of notice on July 29, 2021.

On June 15, 2021, the administrative law judge (ALJ) issued Order No. 2, establishing a deadline of August 9, 2021 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on sufficiency of notice. Therefore, this pleading is timely filed.

**I. NOTICE**

Order No. 2 required Undine to provide notice of the application as described in the June 14, 2021 memorandum of Heidi Graham, using the forms attached to Staff’s recommendation. On July 29, 2021, Undine filed proof of notice and proof of publication consistent with Staff’s recommendation.<sup>1</sup> Staff recommends that the proof of completed notice filed by Undine on July 29, 2021 be found sufficient.

**II. CONCLUSION**

Staff respectfully requests the issuance of an order deeming Undine’s proof of completed notice sufficient.
