#### RESOLUTION NO. 2021-8 RESOLUTION DESIGNATING THE NEWSPAPER OF GENERAL CIRCULATION FOR LUMBERTON MUNICIPAL UTILITY DISTRICT

WHEREAS, Lumberton Municipal Utility District (the "District") must from time to time satisfy the requirement of general, special or local laws to publish notices in a newspaper of general circulation in the District;

WHEREAS, such notice shall be any matter, including a proclamation or advertisement, required or authorized by law to be published in a newspaper by a governmental entity or representative pursuant to Texas Government Code §2051.041;

WHEREAS, a newspaper in which notice is published must (i) devote not less than twenty-five (25%) percent of its total column lineage to general interest items, (ii) be published at least once each week, (iii) be entered as second-class postal matter in the County where published, and (iv) have been published regularly and continuously for at lease twelve (12) months before a governmental entity or its representative may publish notice;
