## COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON SUFFICIENCY OF NOTICE AND PROPOSED PROCEDURAL SCHEDULE

On May 17, 2021, Lumberton Municipal Utility District (Lumberton MUD) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 10929 in Hardin County. On June 2, 2021, Lumberton MUD filed an amended application. On July 21, 2021, Lumberton MUD filed supplemental information and requested to amend its sewer CCN No. 20367. On July 22, 2021, Lumberton MUD filed supplemental mapping information. On October 5, 2021, October 13, 2021, and November 4, 2021, Lumberton MUD filed its proof of notice.

On October 18, 2021, the administrative law judge (ALJ) filed Order No. 4, establishing a deadline of November 15, 2021 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation on the sufficiency of notice and to propose a procedural schedule. Therefore, this pleading is timely filed.

### I. SUFFICIENCY OF NOTICE

Lumberton MUD filed an Affidavit of Notice to Current Customers, Landowners, Neighboring Utilities, and Affected Parties on November 5, 2021, indicating that notice was sent on September 23, 2021 and October 22, 2021. Lumberton MUD also included a list of the individuals and entities to whom notice was provided on October 22, 2021 and copies of those notices, each of which included a map that was deemed sufficient during administrative review. Further, Lumberton MUD also included copies of amended notices that were sent on October 27, 2021 to affected landowners, to amend the notices sent on September 23, 2021 with a copy of the sufficient map. Lastly, Lumberton MUD filed the affidavit within 30 days of providing the notices and amended notices. Staff has reviewed the proof of individual notice and recommends that

Lumberton MUD provided individual notice in accordance with Staff's recommendations on proposed notice filed on August 25, 2021. As such, Staff recommends that individual notice be found sufficient under 16 Texas Administrative Code (TAC) § 24.235(b).

As for published notice, Staff previously recommended that Lumberton MUD publish notice of the application once each week for two consecutive weeks in a newspaper of general circulation in Hardin County, in accordance with 16 TAC § 24.235(c), which requires that notice be published in the same county where the CCN amendment is being requested. On October 5, 2021 and October 13, 2021, respectively, Lumberton MUD filed the newspaper tear sheets and an Affidavit of Publication to prove that it published notice in a newspaper of general circulation in Jefferson County through the Beaumont Enterprise on September 25, 2021 and October 2, 2021. As such, the affidavit was filed within 30 days of the last publication date, but notice was not published in the required county. On November 5, 2021, Lumberton MUD requested a good cause exception to the requirement that notice be published in Hardin County. To support its request, Lumberton MUD included a resolution, adopted on August 16, 2021, in which Lumberton MUD designated the Beaumont Enterprise as its newspaper of general circulation. Lumberton MUD also argued that the Beaumont Enterprise is the largest newspaper in the area and that numerous Hardin County residents receive the newspaper. Staff has reviewed the proof of published notice and Lumberton MUD's arguments for a good a cause exception and is not opposed to Lumberton MUD's request. As such, Staff recommends that published notice be found sufficient under 16 TAC § 24.235(c) and that Lumberton MUD's good cause exception be granted with respect to the requirement that notice be published in Hardin County, the county in which the CCN amendment is being requested.

## II. PROPOSED PROCEDURAL SCHEDULE

In accordance with Staff's recommendation that notice be found sufficient and that Lumberton MUD's request for a good cause exception on published notice be granted, Staff proposes the following procedural schedule:

## III. CONCLUSION

For the reasons detailed above, Staff recommends that notice be found sufficient, that Lumberton MUD's request for a good cause exception on published notice be granted, and that the proposed procedural schedule be adopted. Staff respectfully requests the entry of an order consistent with these recommendations.
