### COMMISSION STAFF'S REQUEST TO AMEND THE PROCEDURAL SCHEDULE

On May 27, 2021, Aqua Texas, Inc. (Aqua Texas) filed an application to amend its certificate of convenience and necessity (CCN) in Collin County. Aqua Texas holds water CCN No. 13201. The requested service area consists of 138 acres, zero existing connections, and 924 proposed connections. Aqua Texas filed supplemental information on June 23, 2021.

On August 23, 2021, the administrative law judge filed Order No. 3, which established a deadline of September 9, 2021, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to provide the final maps, certificates, and tariffs, if appropriate, to Aqua Texas. Staff requests to amend this deadline, which was incorrectly presented in Staff's original proposed procedural schedule.

# I. REQUEST TO AMEND PROCEDURAL SCHEDULE

In its original recommendation on sufficiency of notice, filed on August 23, 2021, Staff's proposed procedural schedule did not allow and adequate amount of time for preparing final maps, certificates, and tariffs, if applicable. To allow Staff to prepare the appropriate materials, Staff requests the adoption of the following procedural schedule:

Deadline for Commission Staff to provide final maps, certificates, and tariffs (if applicable), to the applicant for review and consent	September 29, 2021 <sup>1</sup>

If no hearing is requested, deadline for Commission Staff to file a final recommendation on the application	October 20, 2021
If no hearing is requested, deadline for the parties to file joint proposed findings of fact and conclusions of law. I Stoff requests additional time to provide final mans on	October 27, 2021

law 1 Staff requests additional time to provide final maps, certificates, and tariffs to the applicant because the assigned attorney will be out of the office the week of September 20, 2021.

#### II. CONCLUSION

For the reasons specified above, Staff respectfully requests that the procedural schedule be amended.
