The amounts in Schedule G-7.4 are the total amounts of Excess Deferred Income Taxes ("EDIT") which include the regulatory gross-up amounts. The amounts in Schedule G-7.9(a) represent the EDIT amounts, excluding the regulatory gross-up amounts, on which the amortization calculations were based. The detail of the EDIT resulting from the Tax Cuts and Jobs Act of 2017, including the breakout of protected and unprotected EDIT, are included in WP G-7.9(a).03 on WP1.
