Regarding the answer to CEP 9-17, provide a more detailed explanation and worksheets for the changes that were made to the assignment of Production O&M expense in the CCOS study. Explain why the Company believes these changes were necessary to comply with the NARUC Cost Allocation Manual.

RESPONSE:

These changes make El Paso Electric Company's ("EPE") cost allocation more consistent with the NARUC Cost Allocation Manual. See EPE's response to FMI 1-17. EPE believes that the NARUC Cost Allocation Manual's approach for classifying production operation and maintenance ("O&M") expenses between demand and energy is widely accepted in the industry. EPE's allocation methodology for production O&M expenses was accepted in its recently litigated case in the New Mexico jurisdiction. Also, EPE prefers a uniform approach that can be applied consistently between jurisdictions.

As described in page 25 of the direct testimony of El Paso Electric Company witness Adrian Hernandez, administrative and general ("A&G") expenses are assigned to rate classes using the LABOR allocator or a labor-related allocation factor derived from the labor expenses contained in the accounts of the applicable functional account grouping. The new functional dynamic allocators listed above are the labor-related allocation factors described in that section of the testimony. A&G expenses related to a specific function (e.g., production, transmission, distribution) are assigned an allocator based on the account description.

The "Dynamic Allocators" tab in the cost-of-service model (EPE Regulatory Case Working Model – As Filed – Dkt 52195) shows how these dynamic allocators were derived.

EPE's policy changed in June 2020 as part of the FASB issued Accounting Standards Update 2016-13, Financial Instruments-Credit Losses (Topic 326). The Large C&I (Commercial and Industrial) customers are considered fully collectible based on payment history and, therefore, are not considered for risk in the monthly uncollectible cost calculation. Should a Large C&I customer become indebted to EPE and be identified as risky, a separate provision for uncollectible cost will be considered ad hoc.
