- **FMI 1-1** Regarding Attachment AN-2, please confirm that Staff is recommending a \$25.4 million decrease to EPE's base revenue requirement. If not confirmed:
 - a. Provide Staff's recommended base revenue requirement for EPE, as well as the revenue deficiency/sufficiency.
 - b. Provide Staff's proposed revenue allocation using Staff's recommended base rate revenue.
- **RESPONSE:** Deny. Please refer to the Errata to the Direct Testimony of Adrian Narvaez filed on Tuesday, November 9, 2021 at Attachment AN-2.
 - a. Staff is recommending a Texas retail revenue requirement of \$545,583,237. This represents a revenue deficiency of \$11,767,793 from the Staff-adjusted EPE Texas retail present revenues of \$533,815,444.
 - b. Staff did not recommend any adjustments to EPE's proposed revenue distribution. Please refer to worksheet "Rev Distribution" in Excel file "52195 Staff's Rate Design Model" in the workpapers to the Direct Testimony of Adrian Narvaez for the revenue distribution consistent with EPE's proposed revenue distribution and Staff's recommended CCOSS.
