## **STAFF** 1-47:

#### **Procurement Card**

Does the Company's requested cost of service include procurement card purchases? If so, please list those purchases by FERC account and amount as well as provide the location of each in the rate filing package. Each item should detail the amount that was directly billed to the Company and the amount that was allocated from an affiliate. Please provide the information on CD.

#### SUPPLEMENTAL RESPONSE:

Yes. El Paso Electric Company's ("EPE" or "Company") requested cost of service includes procurement card purchases. Staff 1-47 Supplemental, Attachment 1, provides a summary (by month) of all procurement card transactions by FERC account, which were paid during the test year, and the location in the rate case filing for each FERC account. Staff 1-47 Supplemental, Attachment 2 – Voluminous, provides a detailed listing of each procurement card purchase recorded in the test year by month with a description of the transaction, vendor and the FERC account that was charged for each transaction.

Purchases for items not included in the requested cost of service are separated at the bottom of the table. Notes for each type of purchase not included in cost of service are provided at the top of the table as follows:

- Purchases for which the Company received a subsequent full or partial credit.
- Advertising, contributions and donations which were limited to amounts allowable as stated in 16 TAC § 25.231(b)(1)(E) and as discussed in the direct testimony of EPE witness Jennifer Borden.
- Costs related to the merger with IIF.

- Personal expenses which were reimbursed by Company employees Personal expenses charged to Company PCards are reimbursed by employees through the cash management process and are credited directly to the FERC account to which the purchase was charged through a journal entry, and therefore have no net impact to cost of service.
- Costs related to the COVID-19 pandemic were removed from requested cost of service and included as a separate rider.
- Purchases of alcohol which will be removed from cost of service in the Company's rebuttal testimony.
