The Commission will consider a proposed order in this docket at a future open meeting.

On October 15, 2021, AEP Texas Inc. and Commission Staff filed proposed corrections to findings of fact 26 and 44, conclusion of law 19, and ordering paragraphs 2(c) and 7. AEP Texas and Commission Staff also suggested that a finding be added after finding of fact 48 stating that AEP Texas has reimbursed Cities for its rate-case expenses incurred in Docket No. 50892. The corrections are appropriate and the proposed order is revised accordingly.

FOF26. Because the calculated demand-reduction goal of 20.83 MW exceeds AEP Texas's program year 2021 demand-reduction goal of 20.6 MW, AEP Texas's demand-reduction goal for program 2022 will use the new calculation of 20.836488 MW.

FOF44. For the purpose of the cost caps, AEP Texas's rate for the residential class is \$0.001190~~\$0.001195~~ per kWh, and AEP Texas's group rate for the commercial classes (except the transmission class) is \$0.000848~~\$0.000851~~ per kWh.

FOF49. AEP Texas has reimbursed Cities for its reasonable and necessary rate-case expenses incurred in Docket No. 50892 in the amount of \$11,083.



COL19. AEP Texas's request to charge \$351,084 to customers for AEP Texas's total ~~underover~~ recovery, including \$10,851 in interest, of its program year 2020 energy-efficiency costs complies with PURA § 39.905(b-1) and 16 TAC § 25.182(d)(1)(A) and (d)(2).

OP2(c). a charge of \$351,084 for the total net under-recovery of program year 2020 energy efficiency costs, including \$10,851 in interest.

~~OP7. Within 30 days of the date of this Order, AEP Texas must reimburse Cities for its reasonable 2021 EECRF rate case expenses incurred in Docket No. 50892 in the amount of \$11,083.~~
