ORDER NO. 5
FINDING NOTICE SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the notice provided by Utilities Investment Company, Inc. and UIC 13 LLC and Monarch Utilities I L.P. regarding the application for sale, transfer, or merger of facilities and certificate rights in Harris, Liberty, and Chambers counties. On August 2, 2021, the applicants filed the affidavit of Brian Bahr, director, rates and regulatory of Monarch Utilities, attesting that individual notice was mailed to all required parties on July 26, 2021.

On August 26, 2021, Commission Staff filed a recommendation regarding applicants' notice and proposed a procedural schedule for continued processing.

The administrative law judge finds applicants' notice sufficient and adopts the following procedural schedule for continued processing of this docket:

Deadline for Commission Staff to request a hearing or file a recommendation on approval of the sale and on the CCN amendment	September 30, 2021
Deadline for applicants to file a response to Commission Staff's recommendation on approval of the sale	October 21, 2021
Deadline for parties to file a joint motion to admit evidence and proposed order approving sale and allowing transaction to proceed	November 12, 2021

¹ Under 16 TAC § 24.239(b), the intervention period shall not be less than 30 days unless good cause is shown. Notice was mailed to the last party on July 26, 2021. Therefore, 30 days after July 26, 2021 is August 25, 2021.
