**SUPPLEMENT TO THE APPLICATION OF UTILITIES INVESTMENT COMPANY
INC. AND UIC 13 LLC AND MONARCH UTILITIES I L.P. FOR SALE, TRANSFER,
OR MERGER OF FACILITIES AND CERTIFICATE RIGHTS IN HARRIS, LIBERTY,
AND CHAMBERS COUNTIES**

Utilities Investment Company, Inc. (UIC) and UIC 13 LLC (UIC 13) and Monarch Utilities I L.P. (Monarch) (collectively, Applicants) file with the Public Utility Commission of Texas (Commission) this Supplement (Supplement) to the Application of UIC and UIC 13 and Monarch for Sale, Transfer, or Merger of Facilities and Certificate Rights in Harris, Liberty, and Chambers Counties (STM Application).

I. PROCEDURAL HISTORY

On June 1, 2021, Applicants filed the STM Application of UIC and UIC 13 and Monarch.¹ On June 2, 2021, the Commission issued Order No. 1, requiring Commission Staff to file comments on the administrative completeness of the application and proposed notice, and requiring Applicants and Commission Staff to file a proposed procedural schedule by July 1, 2021.² On June 11, 2021, Applicants conferred with Commission Staff regarding the contents of the STM Application and determined that additional mapping material is necessary to complete the application.

II. SUPPLEMENT TO THE APPLICATION

As a result of the June 11, 2021 meeting between Applicants and Commission Staff, it was determined that additional mapping material is necessary to complete the STM Application for areas that would be included in UIC 13's service territory, and transferred to Monarch in the current proceeding, pending the approval of the CCN Amendment Application in Docket No. 51814.³ Therefore, Applicants file this Supplement, including the attached supplemental mapping information, solely for the purposes of Commission Staff's full review of the STM Application.

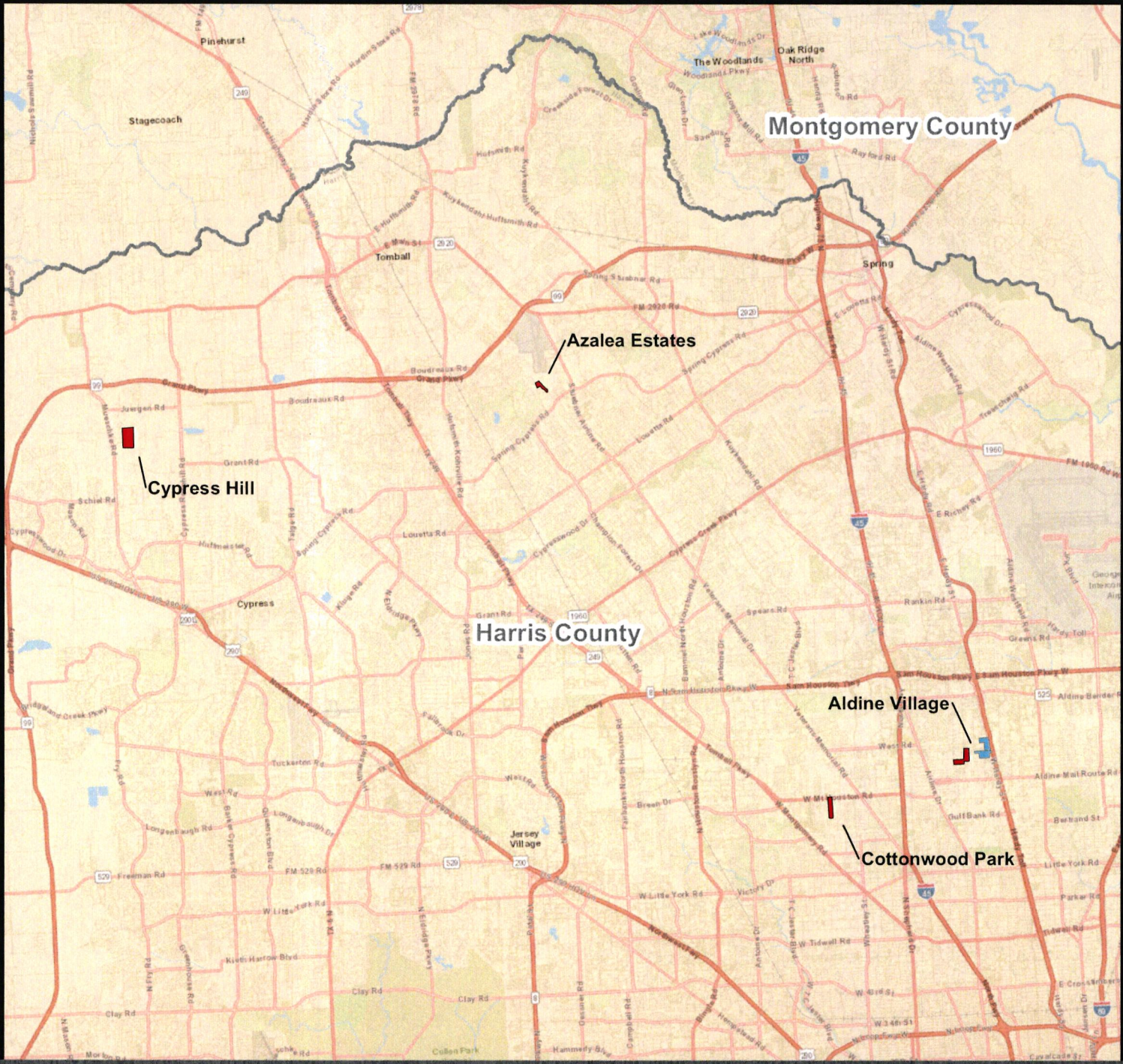

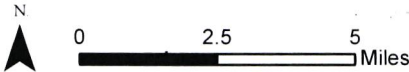

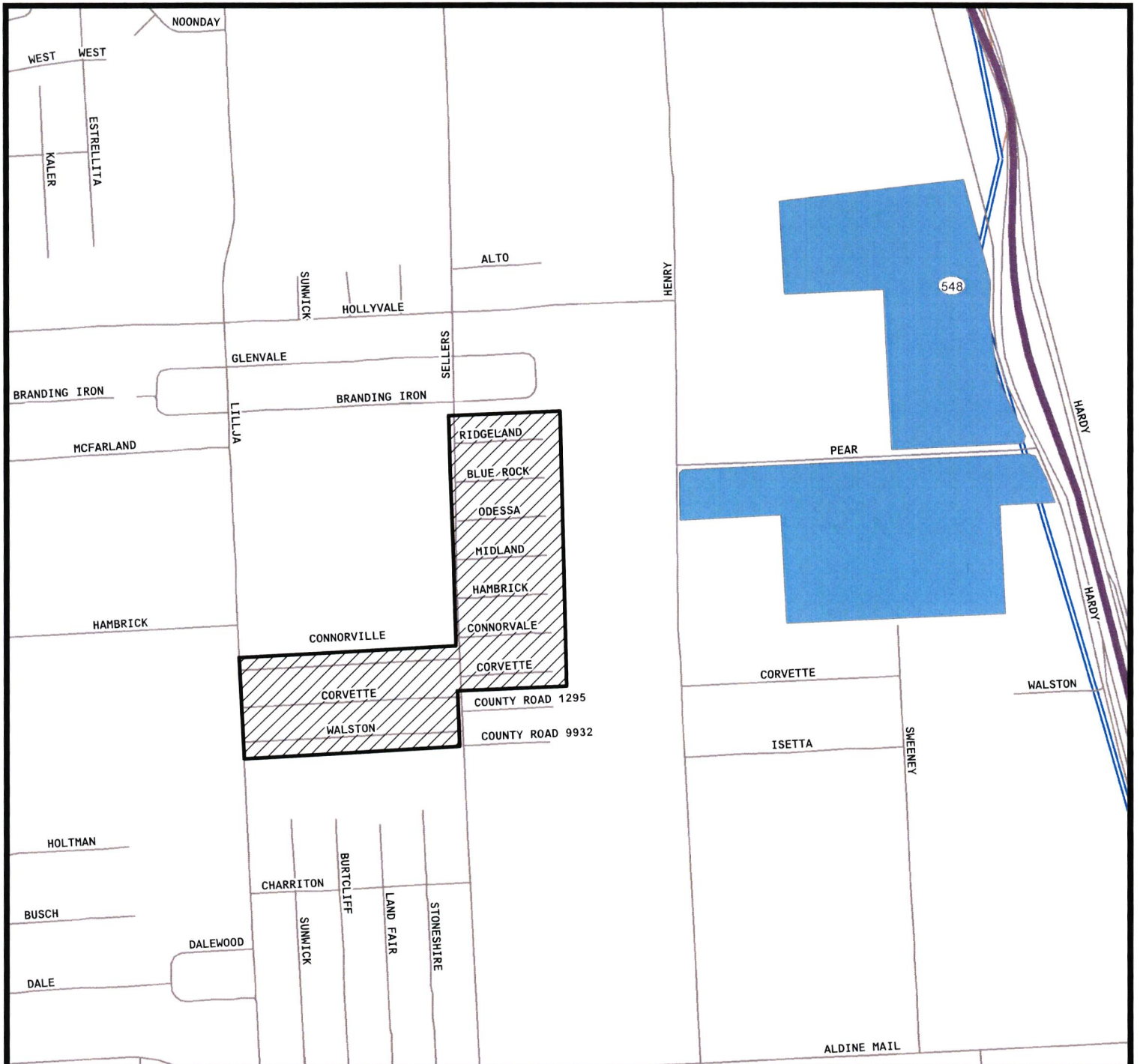

Requested Area - Cottonwood Park Water System

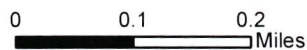

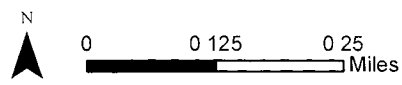

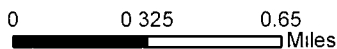


Requested Area - Cypress Hill Water System

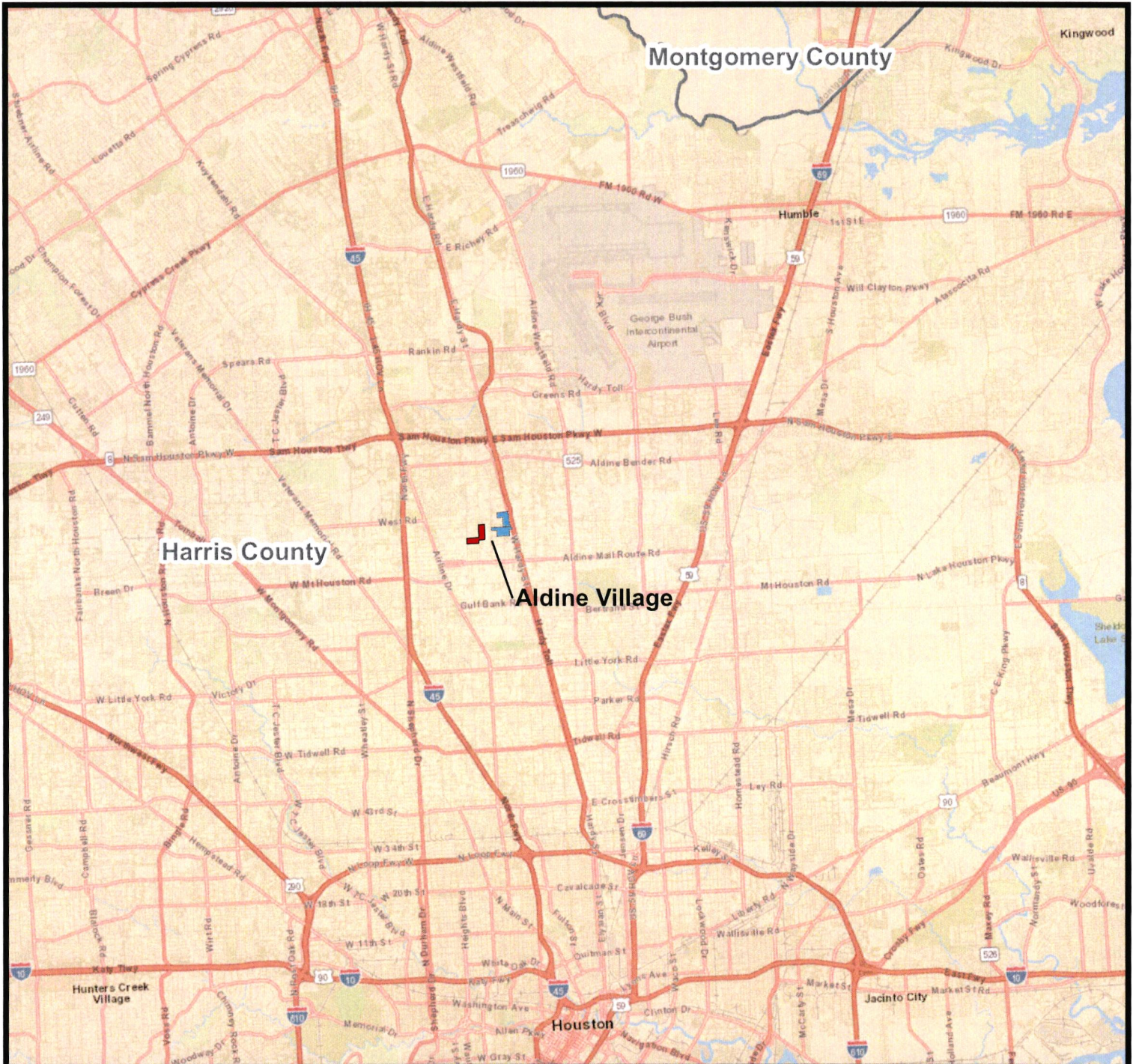

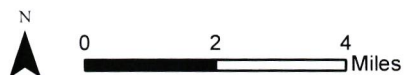

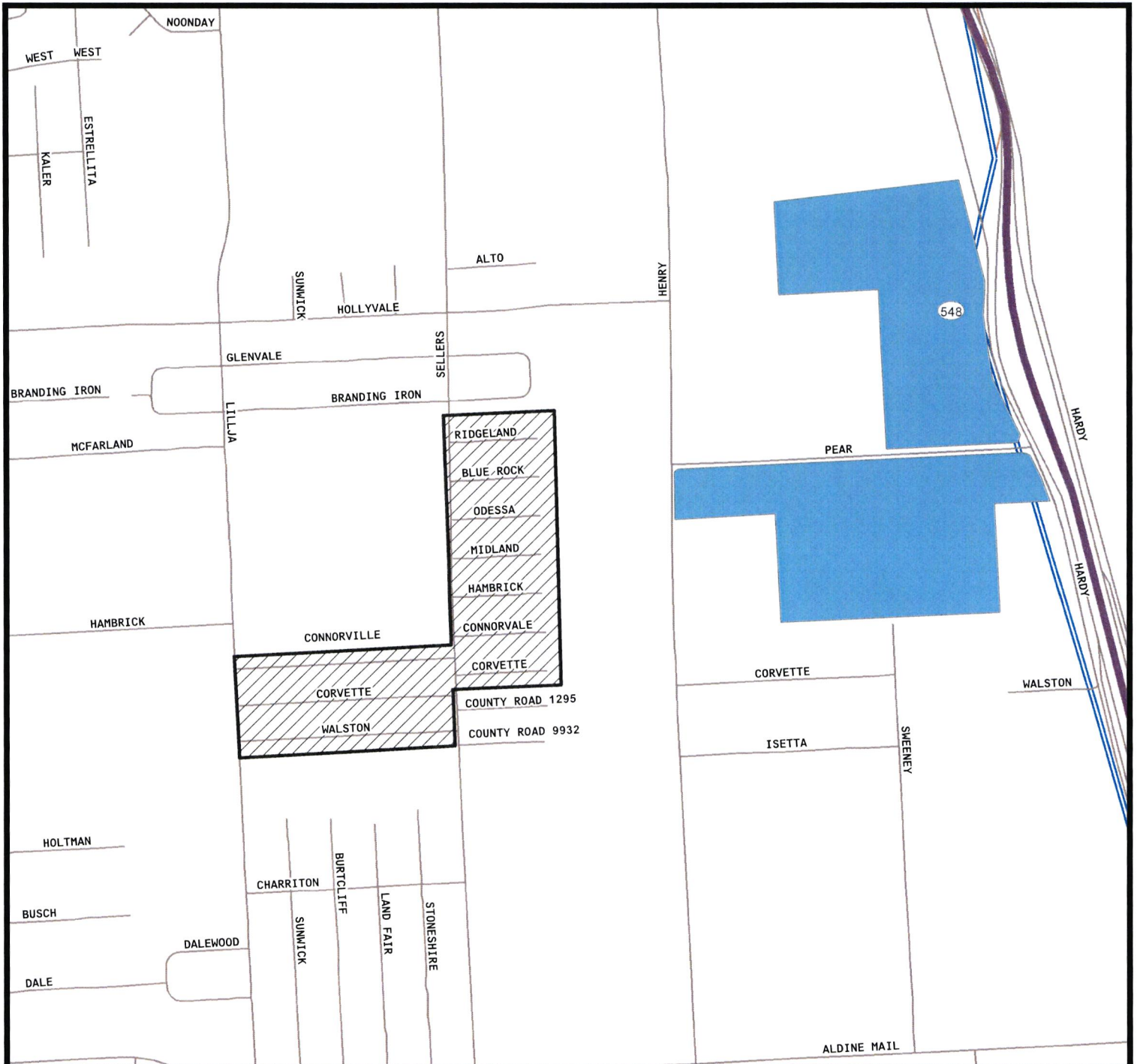
