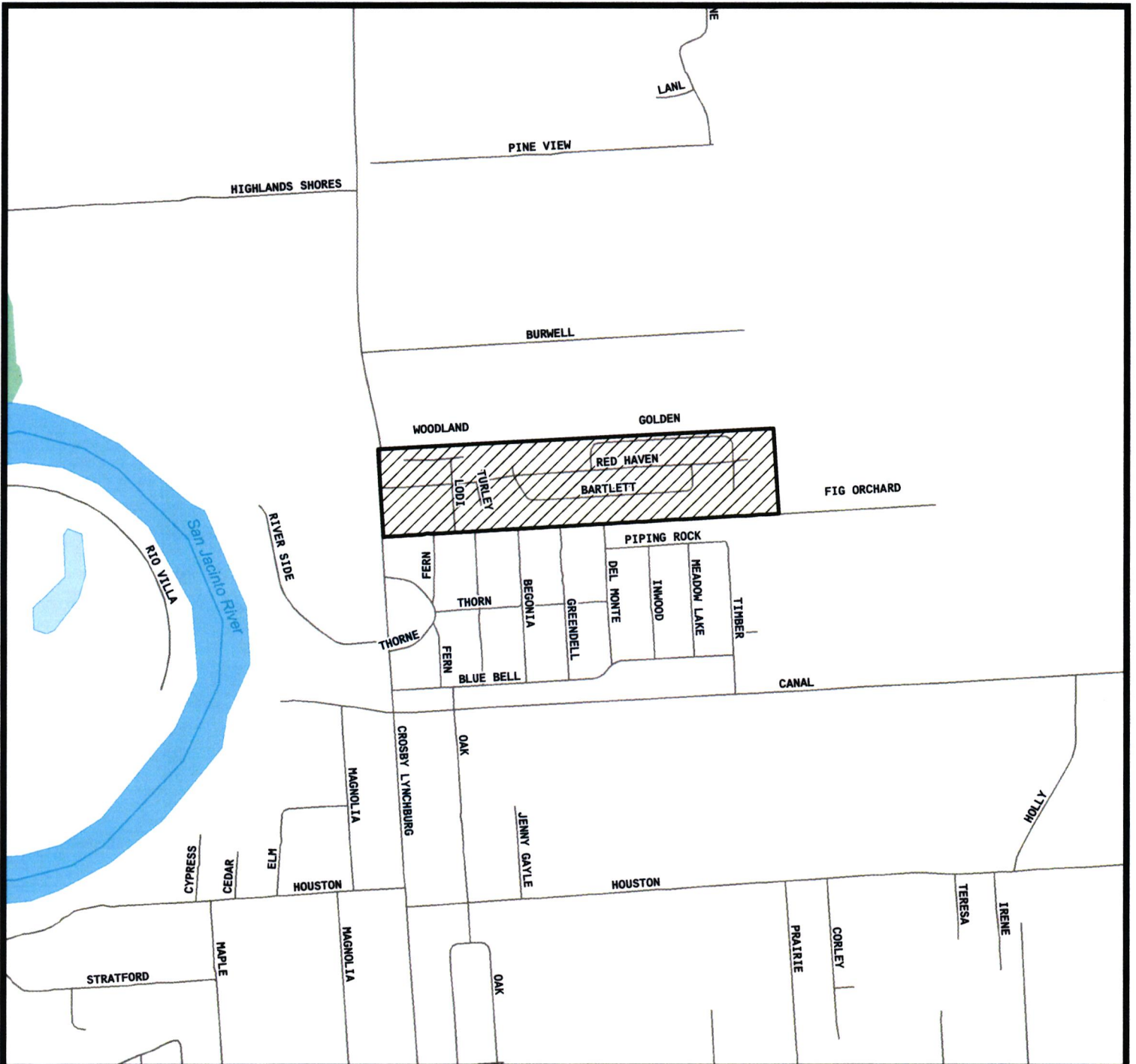


Requested Area - Greenbriar Water System

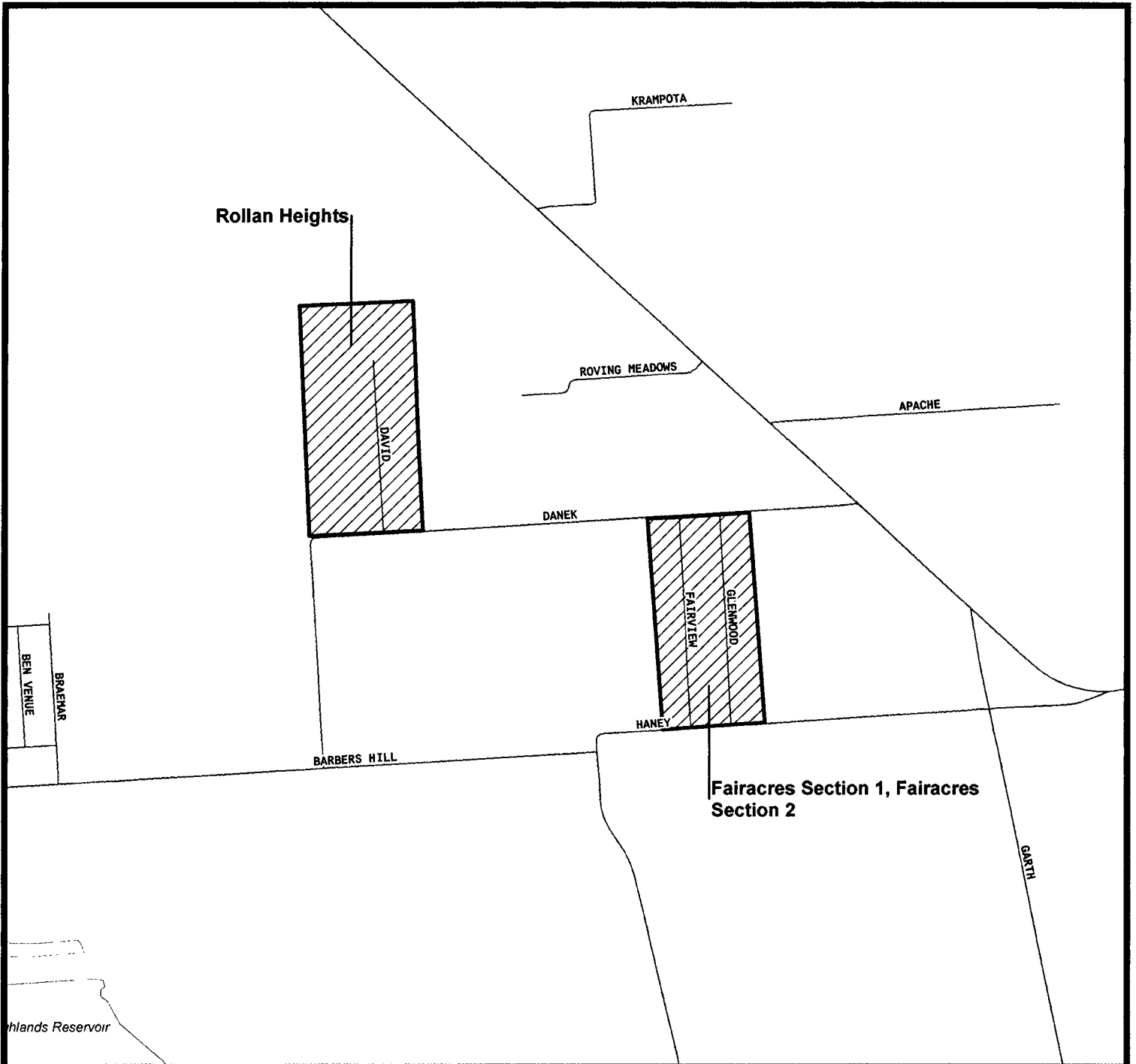

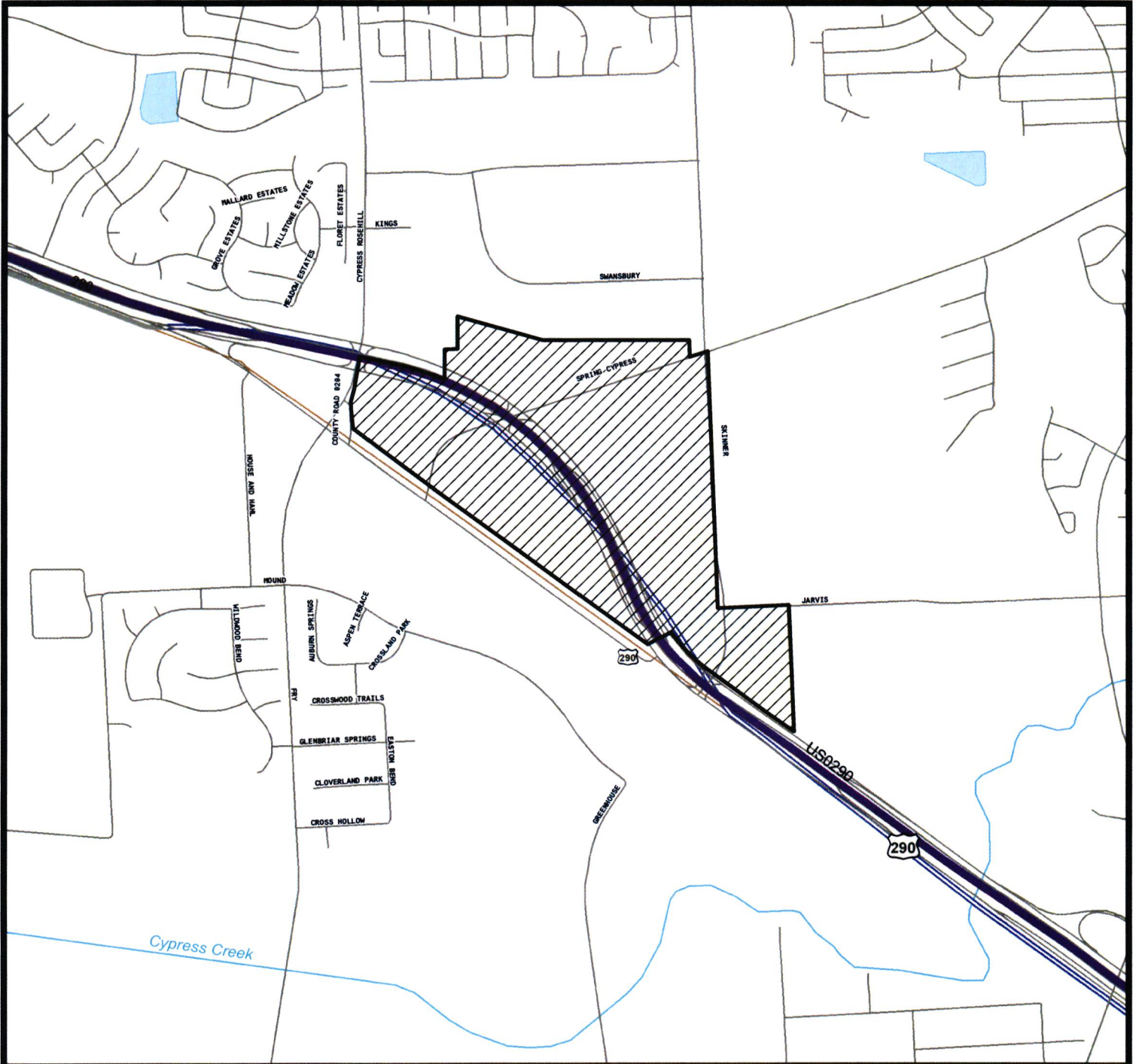

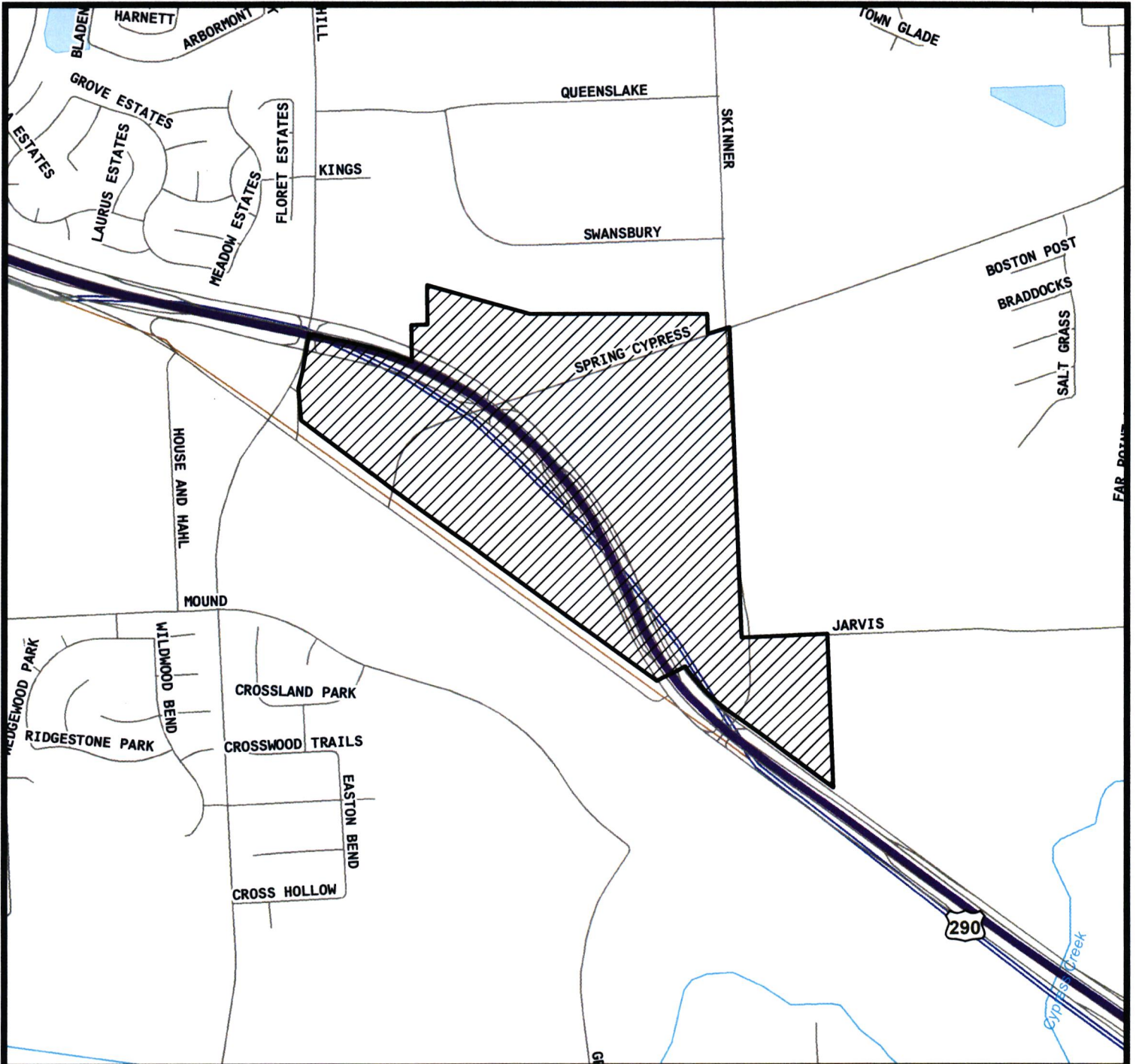


Requested Area - Orchard Crossing Sewer System

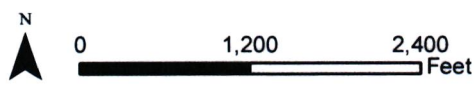

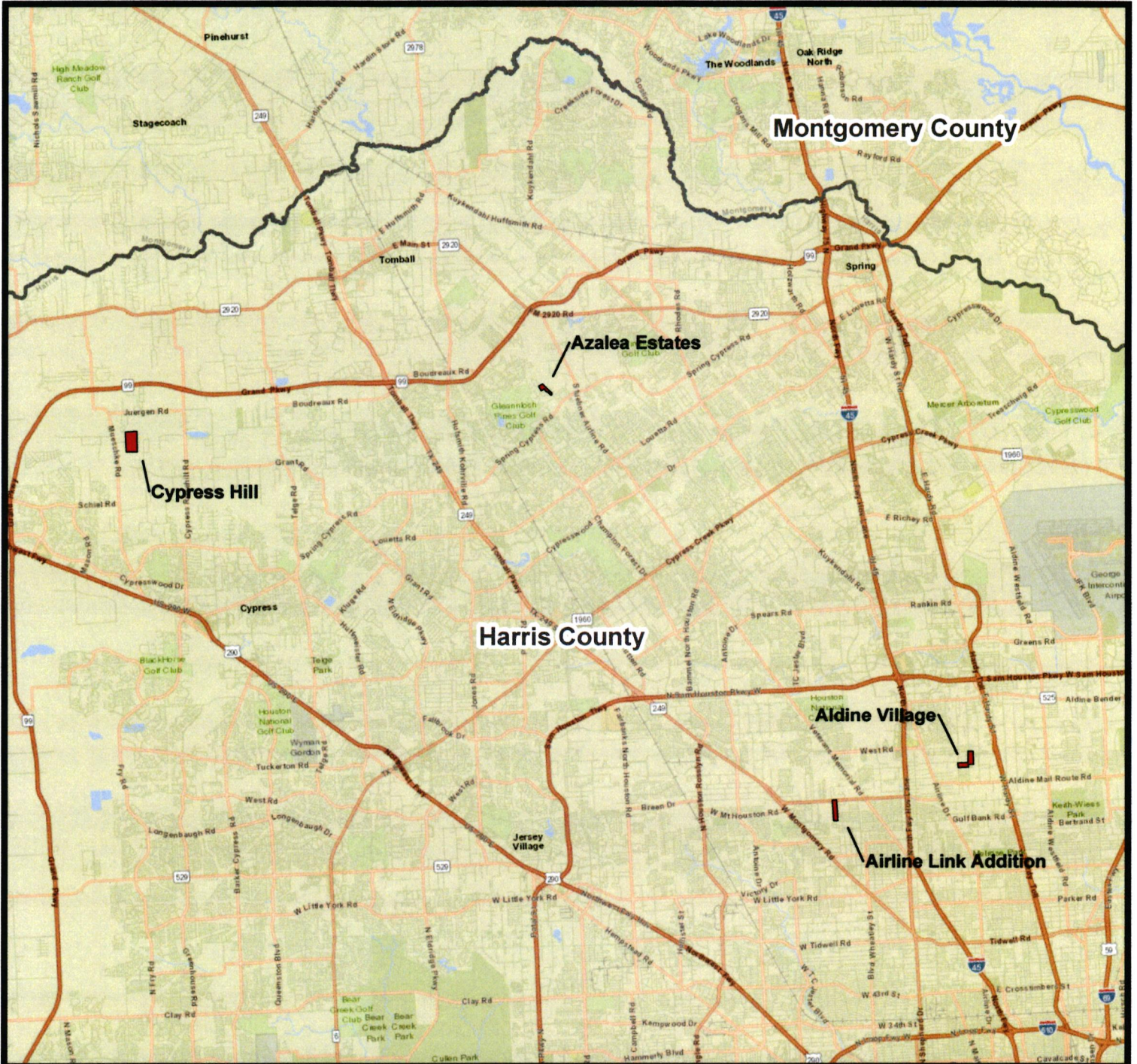


Requested Area - Spring Cypress Shopping Center Sewer System

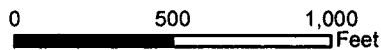


Requested Area - Aldine Sewer System

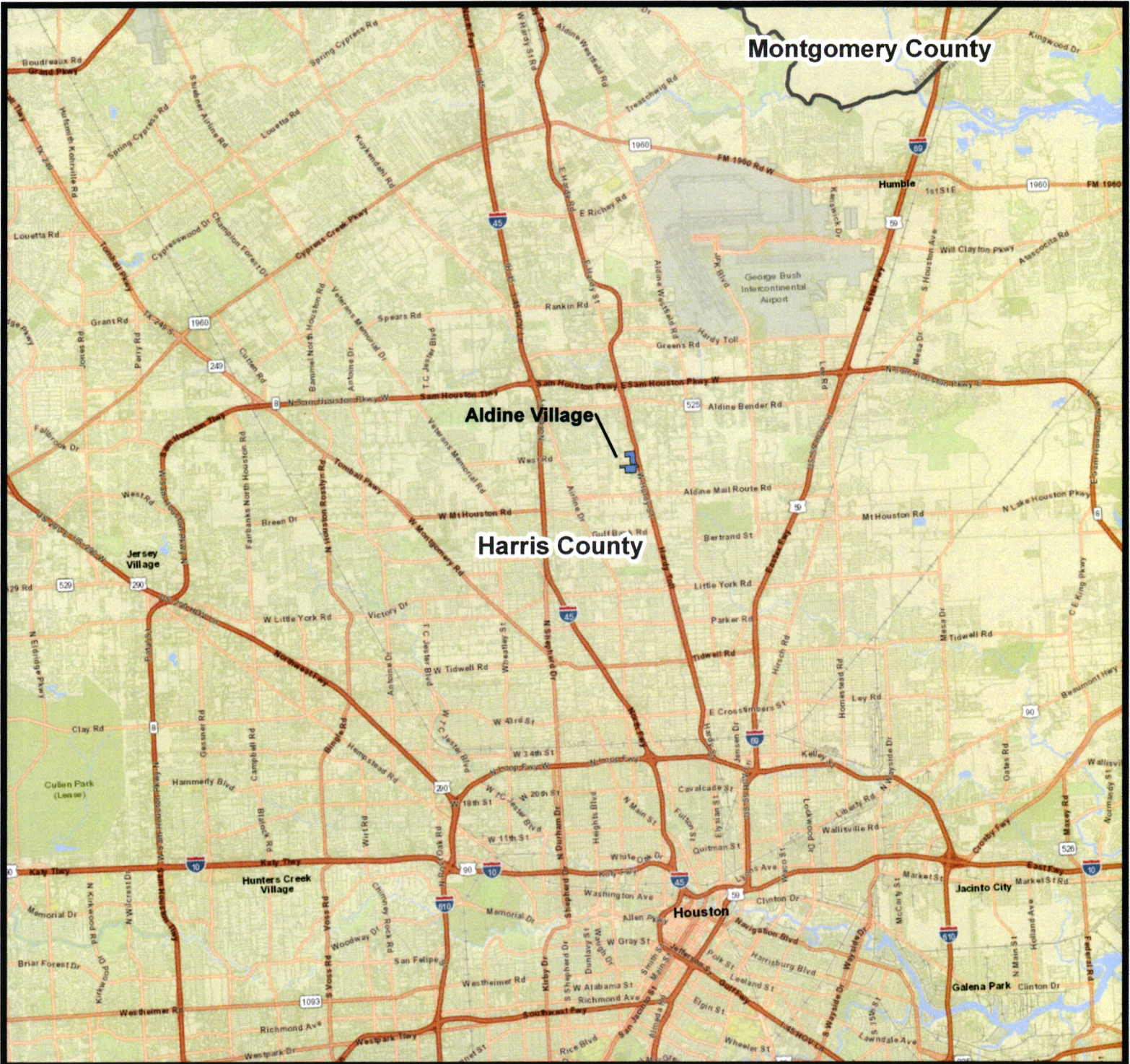
