Re: *CSWR-Texas Utility Operating Company, LLC's Notice of Extension Within Territory Already Served*

Pursuant to Texas Water Code § 13.243 and 16 Tex. Admin. Code (“TAC”) § 24.229(a), CSWR-Texas Utility Operating Company, LLC (“CSWR Texas”) submits this notice of an extension of water service to an area located contiguous to service territory it already serves under certificate of convenience and necessity (“CCN”) Number 13290. The affected area is located within the Hillside Estates subdivision, which CSWR Texas was approved to serve in Docket No. 50989. Following the acquisition and transfer of service obligations, CSWR Texas determined based on its customer list that the Public Utility Commission Texas’s (“Commission”) existing mapping does not reflect a portion of the subdivision that had been served by the former owners since at least the 1980s.

The subject area is located contiguous to CSWR Texas’s existing service territory: the point of ultimate use is within one quarter mile of the outer boundary of the existing certificated service area; the area is not receiving similar service from another retail public utility; and the area is not located inside another retail public utility’s certificated service area as the former owners of this system have been serving this area for decades. Accordingly, pursuant to Texas Water Code § 13.243 and 16 TAC § 24.229 (a)(1)(A), an amendment to CSWR Texas’s CCN is not necessary.

However, 16 TAC § 24.229(a)(2) requires that whenever an extension is made under 16 TAC § 24.229(a)(1)(A), the utility making the extension must inform the Commission of the extension by submitting, within 30 days of the date service is commenced, a copy of a map of the service area clearly showing the extension, accompanied by a written explanation of the extension.

This notice is being filed to comply with 16 TAC § 24.229(a)(2). Mapping files showing the existing service area and extension are attached to this notice as Attachment 1. Digital mapping files are also being provided for the Commission’s convenience.

 OVERALL LOCATION - AUSTIN COUNTY



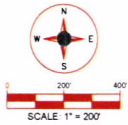
