TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

NOW, Mount Zion Water Supply Corporation ("Mt. Zion") and files this Request for an Extension. In support thereof, Mt. Zion would show the following.

On September 15, 2021, the Administrative Law Judge filed Order No. 4 – Finding Application Deficient, Establishing Deadlines and Opportunity to Cure. Order No. 4 requires Mt. Zion to supplement the application to cure the deficiencies as described in the September 13, 2021 memorandum of Patricia Garcia by October 13, 2021. Therefore, this pleading is timely filed.

Pursuant to 16 Texas Administrative Code § 22.4(b) Mt. Zion may request that the time allowed to file any documents be extended for good cause. Mt. Zion must supplement the application to cure any deficiencies by October 13, 2021. The map showing Mt. Zion's CCN is in storage and it has had a difficult time retrieving the map. Mt. Zion is requesting a thirty-day extension to supplement the application to cure the deficiencies. Attorney for Commission Staff is unopposed to this extension.
