COMES NOW Mount Zion Water Supply Corporation, Applicant, ("Mt. Zion") and files this its Response to Order No. 5. This Response is timely filed. Mt. Zion would respectfully show as follows:

The Commission Staff filed a memo on September 13, 2021, asserting that the area from which Mt. Zion seeks decertification is not within Mt. Zion's certificated area. Mt. Zion hereby submits its Certificate of Convenience and Necessity provided by the Texas Natural Resource Conservation Commission.¹ It describes Mt. Zion's service area as:

The area covered by this certificate is located approximately 2 miles northeast of downtown Rockwall, Texas on State Highway 549. The service area is generally bounded on the north by the Collin County line, on the east and south by State Highway 66 and on the west by State Highway 205 in Rockwall County, Texas.

Dual certification exists in a portion of the area with Lavon Water Supply Corporation, CCN No. 10066.

Mt. Zion asserts that the subject property is within said CCN area and the property should be decertified.
