**COMMISSION STAFF’S RECOMMENDATION ON ADMINISTRATIVE
COMPLETENESS AND NOTICE AND PROPOSED PROCEDURAL SCHEDULE**

On June 23, 2021, Mount Zion Water Supply Corporation (Mount Zion) filed an application to amend water certificate of convenience and necessity (CCN) No. 10088 in Rockwall County.

On June 24, 2021, the administrative law judge (ALJ) filed Order No. 1, establishing a deadline of July 23, 2021 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the application and proposed notice and to propose a procedural schedule for the further processing of this docket. Therefore, this pleading is timely filed.

I. REQUEST FOR AN EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to conduct its review of the application. Accordingly, Staff respectfully requests the entry of an order extending the deadline for Staff to file its comments on the administrative completeness of the application and proposed notice and to propose a procedural schedule to August 13, 2021.
