## COMMISSION STAFF'S REQUEST FOR EXTENSION OF TIME

On June 23, 2021, Mount Zion Water Supply Corporation (Mount Zion) filed an application to amend water certificate of convenience and necessity (CCN) No. 10088 in Rockwall County. On August 10, 2021, Mount Zion filed a revised petition.

On July 19, 2021, the administrative law judge (ALJ) filed Order No. 2, establishing a deadline of August 13, 2021 for the Staff of the Public Utility Commission of Texas (Staff) to file comments on the administrative completeness of the application and proposed notice and to propose a procedural schedule for the further processing of this docket. Therefore, this pleading is timely filed.

## I. REQUEST FOR AN EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to conduct its review of the revised application filed on August 10, 2021. Accordingly, Staff respectfully requests the entry of an order extending the deadline for Staff to file its comments on the administrative completeness of the application and proposed notice and to propose a procedural schedule to September 13, 2021.

#### II. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to September 13, 2021 to file its comments on the administrative completeness of the application and proposed notice and to propose a procedural schedule for further processing of the docket.
