ORDER NO. 4 FINDING NOTICE SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the notice provided by the applicants regarding the application for the sale, transfer, or merger of facilities and certificate rights in Bastrop and Caldwell counties.

On September 14, 2021, the applicants filed: (1) the affidavit of Dave McMurry, general manager of Aqua Water Supply Corporation, attesting that notice was provided to current customers, landowners, neighboring utilities, and affected parties on August 26, 2021; (2) the affidavit of Paul L. Pittman, general manager of Polonia Water Supply Corporation, attesting that notice was provided to current customers, landowners, neighboring utilities, and affected parties on September 10, 2021; and (3) a sample notice to current customers, neighboring systems, and cities with maps.

On September 30, 2021, Commission Staff recommended the notice be found sufficient.

The administrative law judge finds the notice sufficient.
