# AQUA WATER SUPPLY CORPORATION AND POLONIA WATER SUPPLY CORPORATION'S REQUEST FOR EXTENSION

COMES NOW, Aqua Water Supply Corporation ("Aqua WSC") and Polonia Water Supply Corporation ("Polonia WSC") (collectively, "Applicants"), and file this request for extension of time. In support thereof, Applicants would show the following:

## I. BACKGROUND

On June 24, 2021, Applicants filed an application (the "Application") for approval of the sale and transfer of certificate of convenience and necessity ("CCN") rights in Caldwell County and Bastrop County. Aqua WSC seeks approval to acquire facilities and to transfer all of Polonia WSC's certificated water service area under Polonia WSC's water CCN Number 10420 to Aqua WSC's CCN Number 10294, and the cancelation of Polonia WSC's water CCN number.

On August 31, 2022, the Honorable Administrative Law Judge issued Order No. 10, establishing a deadline of September 30, 2022 for Commission Staff to provide final maps, certificates, and tariffs (if applicable), to the applicants for review and consent. Order No. 10 further established a deadline of October 6, 2022, for the Applicants to file signed consent forms with the Commission. This pleading is therefore timely filed.

# II. REQUEST FOR EXTENSION

Pursuant to 16 Texas Administrative Code § 22.4(b), Applicants respectfully request to extend the deadline to file their signed consent forms with the Commission. On September 30, 2022, Commission Staff provided the Applicants with the proposed final map and certificates for review and consent. Aqua WSC identified deficiencies in the proposed map provided by Commission Staff, and Aqua WSC requires additional time to coordinate with Commission mapping staff to address these deficiencies. Aqua WSC respectfully requests the entry of an order extending the deadline for Applicants to file signed consent forms to October 13, 2022. This request is not intended for the purpose of unnecessary delay, and has not been caused by neglect, indifference, or lack of diligence.

## III. CONCLUSION

Applicants respectfully request the issuance of an order granting Applicants' request and extending the deadline to file signed consent forms with the Commission to October 13, 2022.
