REQUEST FOR AN EXTENSION BY MERITAGE HOMES OF TEXAS, LLC,

On June 30, 2021, Meritage Homes of Texas, LLC (“Meritage”) filed a petition for streamlined expedited release of approximately 273 acres of land within the boundaries of the City of Melissa’s (“Melissa”) water certificate of convenience and necessity (“CCN”) No. 11482 and North Collin Special Utility District’s (“NCSUD”) CCN No. 11035 in Collin County, under Texas Water Code (“TWC”) § 13.2541 (b) and 16 Texas Administrative Code (“TAC”) § 24.245(h).

On July 2, 2021, the administrative law judge (“ALJ”) filed Order No. 1, establishing a deadline of July 30, 2021 for the Staff (“Staff”) of the Public Utility Commission of Texas (“Commission”) to file comments on the administrative completeness of the application and notice.

I. REQUEST FOR EXTENSION

Under 16 TAC § 22.4(b), Meritage may request the time allowed for filing any documents be extended for good cause. On July 21, 2021, Meritage and Staff met via videoconference to discuss the filing of a Motion to Sever to maintain the current docket with the City of Melissa and file a separate petition for NCSUD to be restyled as a new docket. Meritage requests an extension until August 13, 2021 to file a Motion to Sever that will include a petition for NCSUD and Staff’s requested supplemental mapping items.

II. CONCLUSION

Meritage respectfully requests the entry of an order extending the July 30, 2021 deadline and to propose a procedural schedule for further processing of the docket.
