## NORTH COLLIN SPECIAL UTILITY DISTRICT'S MOTION TO INTERVENE

COMES NOW, NORTH COLLIN SPECIAL UTILITY DISTRICT (North Collin SUD) and files this Motion to Intervene pursuant to 16 Texas Administrative Code (TAC) §22.101, et. seq. In support thereof, North Collin SUD respectfully would show as follows:

- 1. On June 30, 2021, Meritage Homes of Texas, LLC (Petitioner) filed a petition for streamlined expedited release from the service areas of City of Melissa under Certificate of Convenience and Necessity (CCN) No. 11482 and North Collin SUD's CCN No. 11035, where the property subject to the Petition is approximately 273 contiguous acres in Collin County.<sup>1</sup>
- 2. North Collin SUD has an interest in maintaining its CCN areas and protecting its investments in its infrastructure, and therefore North Collin SUD requests party status to allow it to continue to argue and respond to substantive issues raised in this proceeding. The staff and consulting engineer of North Collin SUD are currently investigating and verifying its water facilities.
- 3. Because North Collin SUD has a justiciable interest which may be adversely affected by the outcome of the proceeding, the Commission should grant North Collin party status as an intervenor.

## **PRAYER**

WHEREFORE, PREMISES CONSIDERED, North Collin SUD respectfully requests that the Commission grant its Motion to Intervene to declared it a party to this proceeding, and grant North Collin SUD any further relief to which North Collin SUD is justly entitled.
