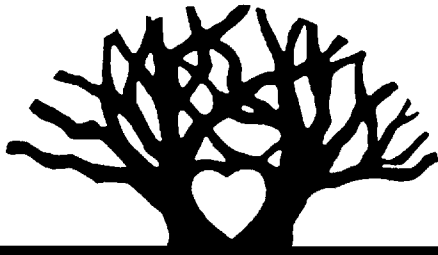

The Village of San Leanna operates a municipal water utility servicing approximately 227 retail water consumers, including 223 residential connections, two commercial connections, and two emergency service facility connections (Manchaca Fire Department and Travis County ESD-5) . The system consists of 2 main wells, pumps, tanks, and treatment plants servicing the North and South sections of the Village of San Leanna. The systems are interconnected and each well is capable of supplying water to the entire Village in the event of an emergency.

Specifications and locations of the facilities are listed below and a map of the main water line and water plant placement is attached.

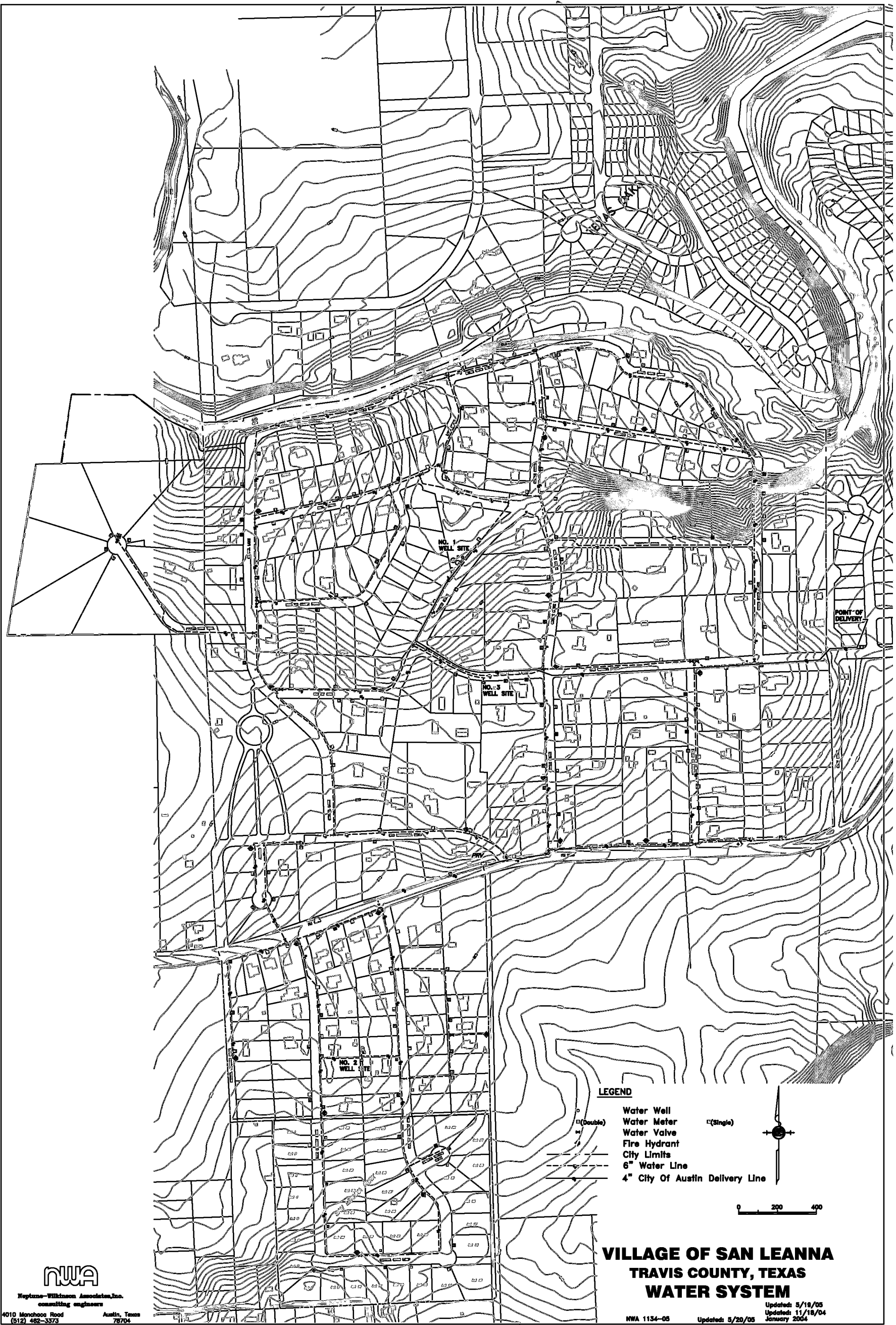
