To Whom It May Concern,

Senate Bill 3 (SB3), a new state law, includes a requirement for water/wastewater utilities to submit critical load information to their electric provider, the Public Utility Commission of Texas (PUCT), the Texas Department of Emergency Management (TDEM), and the local County Office of Emergency Management
