To Whom it May Concern:

AWR Services, on behalf of the City of Cottonwood Shores, submits the following information in compliance with the Texas Water Code (TWC) § 13.1396 – Coordination of Emergency Operations.

- 1. Per the guidelines set forth by the Texas Commission on Environmental Quality (TCEQ), submission of an Emergency Preparedness Plan (EPP) for affected utilities is required on or before March 1, 2022. The EPP for the City of Cottonwood Shores is currently in process as well as the TCEQ's notification of acceptance will be provided.
- 2. The following water facility within the City of Cottonwood Shores qualifies for critical load status:
 - a. The City of Cottonwood Shores Water Treatment Plant, (Castle Terrace SWTP)
 303 Hedges Drive, Marble Falls, TX 78657
 - b. Any water system facilities associated with TX0270013 as identified by address on Exhibit A attached.
