Dear PUC,

The City of Allen is formally submitting this Critical Load Status Letter for compliance with the required information under Senate Bill 3, of the 87th Legislature and Texas Water Code (TWC) 13.1396 and being defined as an affected utility by TWC 13.1394.

The City of Allen (PWS #0430025) provides water distribution and sewer collection within the City limits. This system consists of approximately 502 miles of water main, 381 miles of sewer main, five (5) ground storage tanks, five (5) elevated storage tanks, six (6) lift stations, two (2) pump stations, and one (1) pressure plans. The system's water service produces an Average Daily Demand (ADD) of approximately 16.143 Million Gallons per Day (MGD).
