- Blue Water Oaks Property Owners Association, Sewer Service and Water Supply Corporation

The location and a general description of all water and sewer facilities that you believe would qualify to be designated as critical load:

- Water
 - Well Site 1:
 - 213 Chambers Drive, Alvarado, TX 76009
 - Electric Meter #: TEA 1600698
 - Power requirement: 3 phase, 120/240 V
 - This is our largest well site capable of providing enough water to sustain our customers on its own. It is comprised of two wells, a 0.03 MG storage tank, two booster pumps, a liquid chlorinator, and a pressure tank.
 - Without power to this or our other well sites in the same area it would be impossible to provide uninterrupted water to our customers.
- Sewer
 - Wastewater Treatment Plant
 - 362 Tranquil Lane, Alvarado, TX 76009
 - Electric Meter #: NXA 2032816
 - Power requirement: 1 phase, 120/240V
 - The treatment plant requires electricity to operate the blowers for the oxidation basin. Only one of the two 7.5 HP blowers needs operate at any time.

- Without this service there is a risk of untreated wastewater discharging to the Lake Alvarado.
- Lift Station 1:
 - 301 Chambers Drive, Alvarado, TX 76009 (Next to 172 Rill Ct)
 - Electric Meter #: TEA 1600686
 - Power requirement: 3 phase, 120/240 V
 - It is comprised of two 9 HP grinders and a control panel.
 - This is our largest lift station that sends all wastewater produced in Blue Water Oaks up to the wastewater treatment plant.
 - This station must operate to prevent the unauthorized discharge of raw wastewater near or in Lake Alvarado.
- Lift Station 2:
 - 285 Chambers Dr, Alvarado, TX 76009
 - Electric Meter #: NXA 2001398
 - Service Area is: Chambers Dr (North of the Magellan Pipeline), Davis Ranch Rd (and off shoots), Cove Ct, and Pilot Point Rd
 - Power Requirement: 1 phase, 240 V
 - This lift station is comprised of two 3 HP grinders.
 - This station must operate to prevent the unauthorized discharge of raw wastewater near or in Lake Alvarado.
- Lift Station 3:
 - West side of - 68 Live Oaks St, Alvarado, TX 76009
 - Electric Meter #: NXA 2033644
 - Service are is: Live Oak St, Red Oaks St, White Oak St and Post Oak St.
 - Power Requirement: 1 phase, 120 V
 - This lift station is comprised of two 1 HP pumps.
 - This station must operate to prevent the unauthorized discharge of raw wastewater near or in Lake Alvarado.
