The Matagorda Waste Disposal and Water Supply Corp. provides Water and Wastewater services to approximately 461 residential and commercial connections.

**Facilities are located as noted below:**

1. **Raw/potable water well and ground storage:** Water office facility located at 362 Peach Street has (1) 52,000 gallon ground storage tank, (2) 250 GPM booster pumps, (1) water well (#2) which feed all potable water connections on an alternate bases with water well #1.
2. **Raw/potable water well and ground storage:** Well #1 located at 800 Louis Street has (1) 50,000 gallon storage tank, (2) 250 GPM booster pumps, (1) water well (#1) which feed all potable water connections on an alternate bases with water well #2.
3. **Wastewater Treatment Plant (WWTP):** The WWTP located at 30 Matagorda Street is a 175,000 GPD Treatment Plant with aeration tank, clarifier tank, digester tank, and a chlorination unit that operates on a 24/7 bases.
4. **River Run South Lift Station** located at 48 Mimosa Lane has (2) pumps which move raw sewage from the area to the WWTP on a 24/7 bases.
5. **River Run North Lift Station** located at 6 Mimosa Lane has (2) pumps which move raw sewage from the area to the WWTP on a 24/7 bases.
6. **Austin Street Lift Station** located at 6 Austin Street has (2) pumps which move raw sewage from the area to the WWTP on a 24/7 bases.
7. **Bay Harbor West Lift Station** located at 1 Caney Street has (2) pumps which move raw sewage from the area to the WWTP on a 24/7 bases.
8. **Bay Harbor East Lift Station** located at 1 Catalapa Street has (2) pumps which move raw sewage from the area to the WWTP on a 24/7 bases.
9. **Magnolia Heights Lift Station** located at 1 Mobile Street has (2) pumps which move raw sewage from the area to the WWTP on a 24/7 bases.
10. **Boat Slip Lift Station** located at 1 Boat Slip Road has (2) pumps which move raw sewage from the area to the WWTP on a 24/7 bases.
11. **Caney Street Lift Station** located at 1001 Caney Street has (2) pumps which move raw sewage from the area to the WWTP on a 24/7 bases.
12. **Wastewater Treatment Plant Lift Station** located at 30 Matagorda Street has (2) pumps which move raw sewage from the area to the WWTP on a 24/7 bases.
13. **Harbor Side Road Station** located at 40 Matagorda Street has (2) pumps which move raw sewage from the area to the WWTP on a 24/7 bases.
14. **Magnolia Street Lift Station** located at 203 Magnolia Street has (2) pumps which move raw sewage from the area to the WWTP on a 24/7 bases.
15. **Cedar Street Lift Station** located at 6 Cedar Street has (2) pumps which move raw sewage from the area to the WWTP on a 24/7 bases.
