 - Populate Column B with New Critical Load Application
 - Please do not add columns or change column headings
 - Please do not change the order of the columns
 - Paste ESI ID numbers into Column L in text format (see tips slide if needed)
 - Insert one ESI ID per row
 - Highlight changes to existing ESI ID information (color fill cell to indicate an update of information)

REMINDER

A critical load designation entitles a customer to advanced notice, if reasonably possible, if Oncor must interrupt delivery service in the event of an emergency. Please be aware that **designation of Critical Load does not guarantee an uninterrupted supply of electricity**. It is the responsibility of the Retail Customer to make arrangements for alternative sources of electric power should a load shed event or localized outage occur.
