In response to PUC Project 52299 requirements we are providing the following information:

1. Utility Name: Brushy Creek Municipal Utility District

Public Water System Number 2460061

- 2. Facilities that qualify for critical load status
  - a) Surface Water Intake

A raw water intake facility on Lake Georgetown consisting of three (3) submersible intake pumps, piping, chemical feed equipment, and valving and a motor control center. One pump is rated at 1,500 gallons per minute (gpm) and the other two pumps are rated at 5,000 gpm.

b) Water Treatment Plant

This facility was completed in 2006 and treats the raw water from Lake Georgetown. It supplies water to over 20,000 residents. The facility is a microfiltration facility. It houses pumps, SCADA, and chemical injection. The treatment process includes coagulation, screening, microfiltration and disinfection. The water treatment plant is rated at 8.2 MGD. Following disinfection, treated water is stored in two 1 MG clear wells that are located onsite and then is pumped into the system using high service pumps that have a combined capacity of 9,200 gpm.
