Dear Sir or Madam:

This letter is to satisfy the requirements of the Public Utility Commission of Texas set forth by Senate Bill No. 3 of the 87th Legislature to meet the Compliance Guide of Texas Water Code (TWC) §13.1396.

It has been determined by the legal counsel of the Lavaca-Navidad River Authority (LNRA) that the LNRA meets the criteria of an "Affected Utility" and therefore qualifies for critical load status. The primary point of contact for affected utility is Patrick Brzozowski, (361) 782-5229, 4631 FM 3131, Edna, TX 77957, and secondary point of contact is Scott Hartl (361) 782-5229.

LNRA's permitted raw water diversions are made at two (2) locations using two (2) independent water diversion systems, the West Water Delivery System located at 5738 FM 3131, Edna, TX 77957, and the East Water Delivery System, located at 5501 FM 3131, Edna, TX 77957.

LNRA's West Water Delivery System delivers water to the City of Corpus Christi who in turn provides water to a seven-county service area in and around Nueces County. LNRA's East Water Delivery system delivers raw water in Jackson County and Calhoun County to LNRA water customers at Formosa Plastics Corporation, Inteplast Group Ltd., and the City of Point Comfort. The Calhoun County Port Authority is also a water customer of LNRA but does not currently receive a water supply. LNRA's water deliveries are made on an ongoing and continuous twenty-four hour basis.

The electric utility companies providing transmission to this area are South Texas Electric Cooperative and American Electric Power (AEP). The retail electric provider to LNRA is Jackson Electric Cooperative. The office of emergency management for Jackson County is managed by Kelly Janica and is located at 115 W. Main, Room 104, Edna, TX 77957.
