According to Senate Bill 3, 87th Legislature, Regular Session - Texas Water Code (TWC) § 13.1394, the City of Corpus Christi falls under the revised definition of an "affected utility" and must meet requirements for preparing for, preventing, and responding to weather emergencies and power outages. Part of meeting these requirements is to file a letter containing specific information to the Public Utility Commission of Texas (PUCT) by November 1, 2021 (Texas Water Code (TWC) § 13.1396). Critical Load Water Utility Facilities

Facility	Location	Description
O.N. Stevens Surface Water Treatment Plant	13101 Leopard St., Corpus Christi TX 78410	The only surface water treatment plant for the City of Corpus Christi. The North, South and wash water return pit meters hold critical load status.
Nueces River Pump Station	13699 Smith Dr., Corpus Christi TX 78410	This pump station is located on Nueces River and pumps raw water to the O.N. Stevens WTP for treatment. The A and B meters hold critical load status.
Staples Pump Station	5501 CR 43, Corpus Christi TX 78415	This pump station distributes treated water to the southside of Corpus Christi and has chlorine-boosting capabilities. The main meter holds critical load status.
Sand Dollar Pump Station	14215 Sand Dollar Ave, Corpus Christi TX 78418	This pump station distributes treated water to the Island area of Corpus Christi and has chlorine-boosting capabilities. The main meter holds critical load status.
