

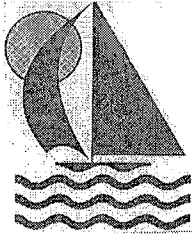

Regarding PUCT Project 52299 (Senate Bill 3, 87<sup>th</sup> Legislature), the following information is provided for the water utility for the City of Highland Haven, CCN No. 13173. The City of Highland Haven, CCN No. 13173 owns the following public water system:

City of Highland Haven Water System, PWS ID No. TX0270099

The following public water system facilities for the City of Highland Haven Water System, PWS ID No. TX0270099 qualify for critical load status:

- The main water plant site located next to 510-A Highland Dr. (between Highland Dr. and Blackbird Dr.), Highland Haven, TX 78654. These facilities include the main water well #1, ground storage tank, pressure pumps, and pressure tanks. Address shown by PEC is 510A Highland Drive (Water Plant).
- The water well #2 located on Redbird (next to 105 Redbird), Highland Haven, TX 78654. Address shown by PEC is 510A Highland Drive (Well).

- The water well #3 located between Blackbird and Highland Dr. (next to 200 Blackbird), Highland Haven, TX 78654. Address shown by PEC is 510A Highland Drive (Well).
- This system currently serves 401 water customers and all properties located within the:
  - City of Highland Haven,
  - Shady Acres sub-division
  - Nobles sub-division
  - Camp Champions youth camp
- See attached Pedernales Electric Coop documentation designating our main water plant and water wells as part of the PEC Critical Loads Program.

Your recent application submission to the PEC Critical Loads Program has been received and reviewed. The following site(s) have been designated as a Critical Load based on criteria outlined by PEC.

This Critical Load designation allows for the site(s) listed to be given priority, but **will not be exempt** from any rotating outages PEC may be called on to deploy as directed by ERCOT. At any time if rotating outages are in effect, you will be notified as such upon the deployment and recall of such events. Priority designation for these sites means that PEC anticipates the ability to provide advanced notice of any rotating outages as well as priority restoration if service at the site is interrupted due to rotating outages.

PEC does not guarantee an uninterrupted, regular, or continuous power supply. Locations registered in the program are not exempt from planned service interruptions, nor are registered members exempt from their financial responsibilities or the termination of service in accordance with PEC policies. When planned outages or service interruptions for nonpayment are scheduled, we will attempt to provide advance notice so preparations can be made. For unplanned outages, PEC will prioritize Critical Loads Program participants for restoration as much as practicable.

As part of the PEC Critical Loads Program, this application and review process will be conducted annually. Sites previously deemed as Critical Loads will be reviewed and have the ability to be added or removed from this designation. PEC will work with members to provide advanced notice when available to mitigate the impact to your business operations.
