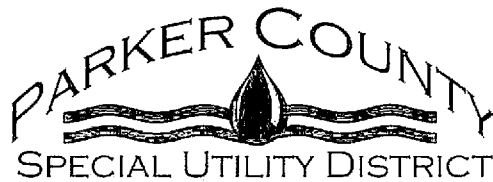

To Whom this Concerns,

Parker County Special Utility District is considered an affected utility that must file information with the Public Utility Commission of Texas (PUCT) in Project 52299. This information must also be filed with each transmission and distribution service provider, the **PUCT**, each retail electric provider (Tri-County), and the office of emergency management of each county (Parker County) where the utility has water facilities that **qualify for critical load status**.

The District has **9** areas that qualify for critical load status which have water pump stations and holding tanks that supplies water service for the Brock, Dennis, Lipan, Millsap, and west of Weatherford at **1)** 190 Ellen Ln- Millsap TX, **2)** 799 Jack Wright Rd- Millsap TX, **3)** 4933 Bennett Rd-Millsap TX, **4)** 100 Grindstone Rd-Brock TX, **5)** 4100 Greenwood Rd-Weatherford TX, **6)** 1651 Cougar Rd (Dennis Pump Station)-Lipan TX, and **7)** 7702 FM 1189 (SugarTree Pump Station)-Lipan TX. The District has a Treatment Plant located at **8)** 1200 Tidwell Rd- Weatherford and an intake line at **9)** Spur 1189 at Brazos River.

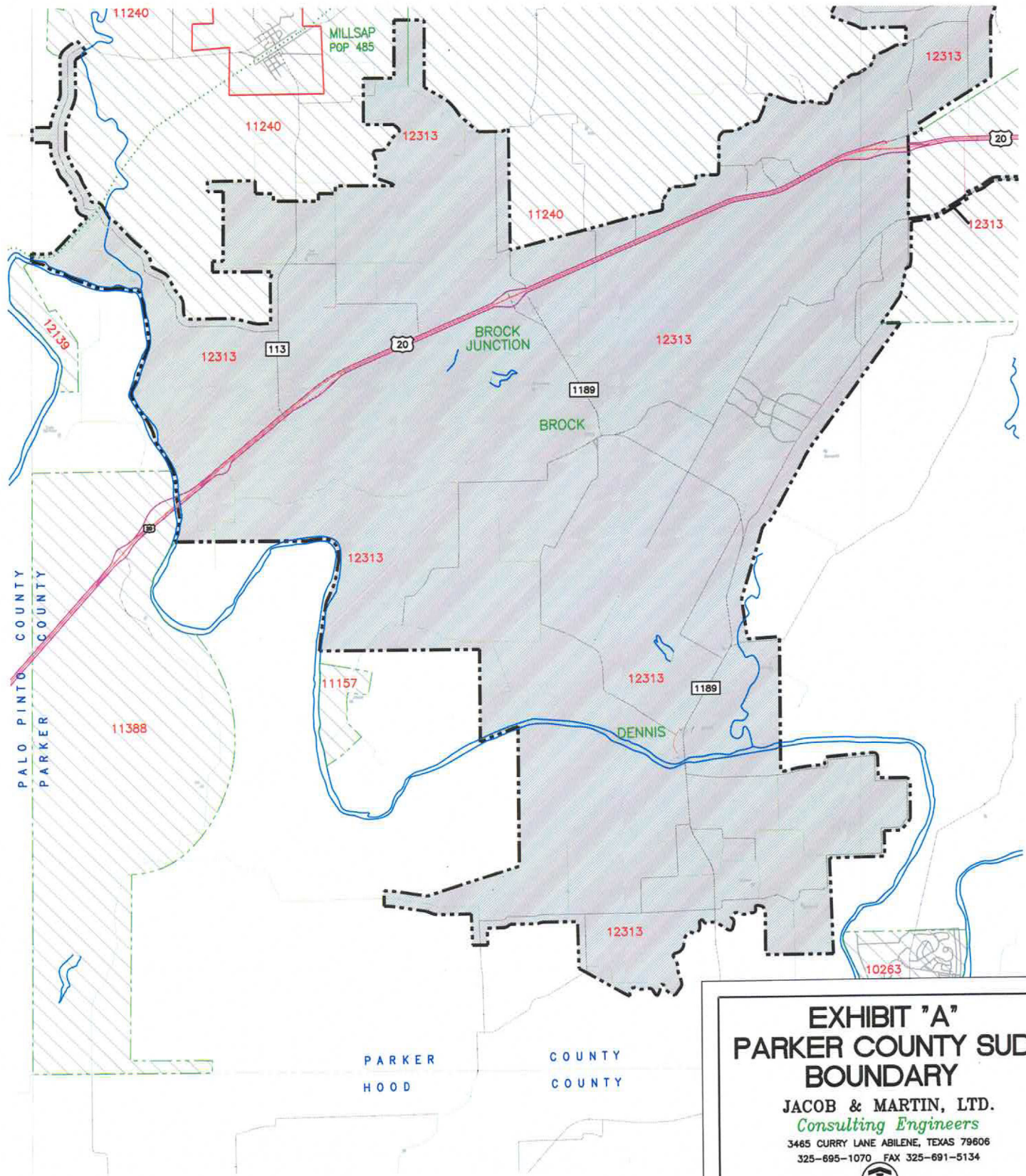
