To Whom It May Concern,

The City of Springtown has 3 locations serving its water treatment and distribution process and 3 locations serving its wastewater treatment as follows:

- <u>Intake Station</u>-located on the west shore of Eagle Mountain Lake at the east end of W Peden Rd, Azle, Tarrant County, TX. Water is procured from Eagle Mountain Lake and sent to our water treatment plant.
- Water Treatment Plant-located at the SW corner of Cardinal Rd and Peden Rd, Azle, Parker County, TX. Water procured from Eagle Mountain Lake is treated and sent to our Booster Station.
- Booster Station-located at 2910 Springfield Rd, Springtown, Parker County, TX.

  Treated water from our Water Treatment Plant is sent from this location into our distribution system and serves the City of Springtown.
- Wastewater Treatment Plant-located at 1361 Walnut Creek Dr, Springtown, Parker County, TX. Residential & commercial property wastewater is sent to this plant to be treated and returned into Walnut Creek.
- <u>Lift Station #1</u>-located in the City of Springtown, Parker County, TX in the 200 block of West Highway 199 at the southwest corner of the intersection of S. Ash St and State Hwy 199.
- <u>Lift Station #2</u>-located in the City of Springtown, Parker County, TX on the west side of N Spring Branch Trail approximately 115' south of E 5<sup>th</sup> St and 115' north of Avagail Ave.
